NOTICE OF RELEASE OF SECURITY INTEREST

WHEREAS, Sun Apparel, Inc. ("Sun Apparel") and NatWest Bank, N.A., ("NatWest"), as Agent for the ratable benefit of certain Banks (as defined therein) entered into a Trademark Security Agreement ("Trademark Security Agreement") dated December 22, 1995;

WHEREAS, pursuant to the Trademark Security Agreement, Sun Apparel granted NatWest, as Agetet, a security interest in Sun Apparel's right, title and interest in and to certain United States trademarks (the "Trademarks"), as security for certain debt obligations of Sun Apparel under a certain Loan Agreement dated as of December 22, 1995 entered into among Sun Apparel, the Banks signatory thereto and Agent (as amended, modified or supplemented thereafter, the "Loan Agreement"), and other instruments and documents executed and delivered in connection therewith, including a certain Security Agreement dated as of December 22, 1995 between Sun Apparel and NatWest, as Agent (as amended, modified or supplemented thereafter, the "Security Agreement") and the Trademark Security Agreement;

WHEREAS, notice of the security interests in the Trademarks was given pursuant to the Trademark Security Agreement, which was filed and recorded in the U.S. Patent and Trademark Office on December 29, 1995 at **Reel 1421, Frame 0848**;


WHEREAS, the indebtedness secured by the Trademarks pursuant to the Trademark Security Agreement and the Security Agreement and under the Loan Agreement and related documents has been fully satisfied;

WHEREAS, Jones Investment Co. Inc., an indirect wholly owned subsidiary of Jones Apparel Group, Inc. is the successor-in-interest to Sun Apparel with respect to the Trademarks; and

WHEREAS, Bank of America ("BoA"), as successor-in-interest to NatWest, desires to release the Trademark Security Agreement, the Security Agreement and its security interests in the Trademarks; and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, BoA hereby relinquishes, releases and terminates any and all claims and security interests that BoA may have in any property obtained pursuant to the Trademark Security Agreement and the Security Agreement, including the Trademarks identified in Schedule A attached hereto.
