Dear Mr. Agovino:

Bristol-Myers Squibb ("BMS") is the successor in interest to certain assets of DuPont Merck Pharmaceutical Co. ("DuPont").

At one time, DuPont was the owner of U.S. Reg. No. 1,415,548 for the trademark FLUMADINE (the "Registration"). According to the records of the U.S. Patent and Trademark Office ("USPTO"), DuPont acquired the Registration on or about February 13, 1992, and assigned the Registration to Forest Laboratories, Inc. ("Forest") on or about July 23, 1992.

Forest has advised that pursuant to a certain "Notice of Security in Trademark" Agreement dated as August 31, 1992 ("Security Interest") between DuPont and Forest, Forest granted a security interest to DuPont in the Registration. DuPont recorded the Security Interest with the USPTO on October 1, 1992, at Reel 0895, Frame 0536.
