**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE dated as of November 24, 2009, from Virgin Entertainment Holdings, Inc. and SK Telecom Co., Ltd. (as successor to SK Telecom USA Holdings, Inc.) (each a "Lender" and collectively, the "Lenders"), to Helio LLC.

WITNESSETH:

WHEREAS, pursuant to the Subordinated Credit Agreement dated as of July 19, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), and the Guarantee and Collateral Agreement dated as of July 19, 2006 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement"), Virgin Mobile USA, L.P. (f/k/a Virgin Mobile USA, LLC; the "Grantor") granted to Lenders a security interest in all of Grantor's right, title, and interest in all Collateral (as defined in the Guarantee and Collateral Agreement);

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Assumption Agreement dated as of August 22, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Assumption Agreement"), by Helio LLC (the "Additional Grantor"), the Additional Grantor granted to Lenders a security interest in and to the Additional Grantor's Collateral (as defined in the Guarantee and Collateral Agreement);

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Additional Grantor entered into that certain Trademark Security Agreement dated as of August 22, 2008, in favor of Lenders (the "Trademark Security Agreement"), granting a security interest (the "Security Interest") in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office, at Reel 3840, Frame 0005 on August 22, 2008; and

WHEREAS, the Lenders now desire to terminate and release the entirety of their Security Interest in the Trademark Collateral under the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lenders hereby state as follows:


1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement.
2. Release of Security Interest. The Lenders hereby terminate, release, and discharge their Security Interest in the Trademark Collateral, including the Trademarks listed in

Schedule I attached hereto, under the Guarantee and Collateral Agreement and the Trademark Security Agreement. To the extent that the Lenders have any right, title, or interest in such Trademark Collateral and proceeds thereof under the Guarantee and Collateral Agreement and the Trademark Security Agreement, including without limitation, any and all causes of action of Additional Grantor which may exist by reason of infringement of the Trademark Collateral, such right, title, or interest shall hereby cease and become void.


