# ORIGINAL

## AGREEMENT FOR TRANSFER OF TRADEMARK

This Agreement for Transfer of Trademark (the "Agreement") is made by and between, Kenneth A. Krasne, acting as Receiver for Soyo Group, Inc., a California corporation, with a principal place of business of 1420 S. Vintage Avenue, Ontario, CA 91761 ("Seller") and Amergence Technology Inc., a California corporation, with a principal place of business of 20480 East Business Parkway, City of Industry 91789 ("Purchaser") and is effective as of August 19, 2009. This Agreement is made with reference to the following facts:

A. To the best of his knowledge, seller is the sole owner and user of the marks registered in the United States Patent and Trademark Office ("USPTO") as contained in Exhibit A to this Agreement (the "Marks"). Seller is also the sole owner and user of all copyright and other intellectual property and common law rights based on or related to the Marks (collectively, the "Intellectual Property Rights").

B. Kenneth A. Krasne (the "Receiver") has been appointed by the California Superior Court, County of Los Angeles to act as the receiver for Seller and the Receiver continues to act in that capacity under the bankruptcy proceeding filed by Seller.

C. The Receiver has agreed / is empowered to transfer and sell Seller's assets, subject to court approval./ confirmation.

D. Seller (by and through the Receiver) and Purchaser have entered into a Bill of Sale for Purchaser to purchase from Seller (by and through the Receiver) certain assets of the Seller, including the Marks, for a total purchase price of \$ 170,300.00 (One hundred seventy thousand and three hundred dollars)(the "Purchase Price"), subject to deductions and adjustments as noted in the Bill of Sale.

E. The contemplated purchase and sale has obtained the approvals required under the letter agreement and the Seller and Purchaser desire to take all necessary acts to conclude the transfer of the purchased assets from Seller to Purchaser.

Now, **THEREFORE**, in consideration of the promises and mutual covenants and agreements set forth below, the parties agree as follows:

**1 Incorporation of Recitals; Consideration.** Recitals A through E above are incorporated into the body of this Agreement as if fully set forth in this Paragraph 1. In partial consideration for the payment by Purchaser to Seller of the Purchase Price, Purchaser purchases from Seller and Seller sells to Purchaser all of Seller's right, title and interest in the Marks, including all Intellectual Property Rights and goodwill in the Marks. Concurrently, Purchaser is purchasing from Seller additional assets with the balance of the Purchase Price, including certain of Seller's domain names registered with Network Solutions, LLC.

**2 Assignment of Marks.** Seller irrevocably sells, assigns, transfers, conveys and delivers to Purchaser (which to the best of his knowledge free and clear of all liens) all rights, title, and interest in, to and under the Marks and the use and registration of the Marks, including all Intellectual Property Rights, together with the goodwill of Seller's business symbolized by the Marks (the "Assigned Property"). These transferred rights include the right to recover for past, present and future infringement of the Marks.

3 Acceptance of Transfer. Purchaser accepts the sale, assignment, transfer, conveyance and delivery of the Assigned Property.

4 Seller's Further Covenants. Seller shall cooperate in a commercially reasonable manner with Purchaser, without further consideration, and as requested, from time to time. Seller shall execute and deliver to Purchaser additional instruments of sale, transfer, conveyance, assignment and confirmation, provide additional materials and information and take additional actions as Purchaser may reasonably deem necessary in order to more effectively transfer, convey and assign to Purchaser, and to confirm Purchaser's title to, all of the Assigned Property.

5 Prohibition on Registration. Seller agrees that neither Seller nor any person or entity affiliated with Seller shall register any marks that may be confusingly similar to the Marks.

6 Choice of Law; Forum. This Agreement shall be interpreted in accordance with the laws of the State of California. All actions, claims or disputes arising under or relating to this Agreement shall be brought in the federal or state courts in the State of California and the parties irrevocably consent to the exercise of subject matter jurisdiction and personal jurisdiction over each of the parties by said courts or to the laying of venue in said courts.

7 Counterparts. This Agreement may be executed in counterparts, each being considered a binding part of the whole. A facsimile signature shall be as binding as an original signature for all purposes.

9 Expenses. Each party shall bear all of its expenses incurred in the performance of this Agreement, regardless of whether the transactions contemplated by this Agreement are consummated.


10. Successors and Assigns. This Agreement is binding on and shall inure to the benefit of the respective successors and assigns of the parties.
