**DEED OF ASSIGNMENT WITH GOODWILL**



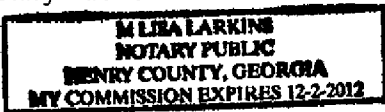
WHEREAS, Assignor is the owner of the trademarks listed in Schedule A attached hereto (collectively, the "Trademarks"); and

WHEREAS, Assignee wishes to acquire all of Assignor's rights in and to the Trademarks and the good will associated therewith;






