**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Termination and Release"), dated as of December **23**, 2009, from JPMorgan Chase Bank, N.A., a national banking association, as Administrative Agent (the "Agent") for certain banks and other financial institutions, parties to the Credit Agreement, dated August 19, 2002, as amended and restated (the "Lenders"), in favor of Birds Eye Group, Inc., successor to Linden Oaks Corporation (the "Obligor"), a Delaware corporation with its principal place of business located at 90 Linden Oaks, PO Box 20670, Rochester, New York 14625.

WITNESSETH:

WHEREAS, pursuant to the Collateral Agreement, dated as of August 19, 2002, as amended and restated as of March 22, 2007, made by the Grantors (as defined therein) in favor of the Agent (the "Collateral Agreement"), a continuing security interest and the right of setoff against certain collateral, including the Trademark Collateral (as hereinafter defined) (the "Security Interest") was granted by the Grantors to the Agent;

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of August 19, 2002, among the Agent and Obligor (the "Security Agreement"), Obligor, by reference to the Collateral Agreement, reaffirmed its intent to grant a Security Interest to the Agent, specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 11, 2002 at Reel 2569, Frame 0385; and

WHEREAS, the Agent now desires to terminate and release the entirety of its and Lenders' Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, the Agent hereby states as follows:

1. Definitions: The term "Trademark Collateral," as used herein, shall mean all right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Collateral Agreement.

2. Release of Security Interest: The Agent, on its behalf and on behalf of the Lenders, hereby terminates the Security Agreement, terminates, releases and discharges the Security Interest in the Trademark Collateral, and hereby assigns, transfers and conveys to Obligor any right, title or interest of the Agent or Lenders in such Trademark Collateral.

3. Further Assurances: The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary or reasonably requested by any Obligor to effect, evidence or record the release of the Security Interest contemplated hereby.


