**RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARK

GETZLER HENRICH further authorizes and requests that the Commissioner of Patents and Trademarks of the United States of America, and the empowered officials of all other governments, to note in the record the termination and release of the security interest heretofore granted to GETZLER HENRICH by RONSON with respect to the Patents and Trademarks and Goodwill associated therewith.
