**NOTICE OF LAPSE OF SECURITY INTEREST
AND SATISFACTION OF OBLIGATION**

THIS NOTICE OF LAPSE OF SECURITY INTEREST AND SATISFACTION OF OBLIGATION (this "Notice") is filed by Ronson Corporation, a New Jersey Corporation (the "Assignor"), hereby notifying the United States Patent and Trademark Office of the lapse of security interest and satisfaction of the Assignor's obligation as more fully set forth herein. Capitalized terms used but not defined herein shall have the respective meaning ascribed thereto in the Agreement (as defined below).

RECITALS

A. On May 16, 1984, a Collateral Patent, Trademark and License Assignment (the "Agreement") was entered into by and among the Assignor, Security Pacific Business Credit, Inc. ("Security Pacific") and Lazere Financial Corporation ("Lazere") (Security Pacific and Lazere are hereinafter collectively referred to as the "Assignee").

B. Pursuant to the Agreement, as security for the repayment of the Obligations, the Assignor granted to Assignee, as and by way of a first mortgage and security interest (the "Collateral Security Interest"), all of the Assignor's right, title and interest in and to all of Assignor's patents, patent applications, trademarks, trademark applications, tradenames, goodwill, copyrights, and licenses (the "Collateral").

C. The Collateral Security Interest was perfected by the filing of UCC-1 financing statements in state and local filing offices (collectively, the "Filed UCC-1 Financing Statements"). In addition, on July 20, 1984, the Agreement was recorded with the United States Patent and Trademark Office and identified at Reel/Frame 0479/0590 as a security interest.


D. On or about November 1, 1985, the Obligations were repaid and satisfied in full and all commitments to lend by the Assignee to Assignor were terminated. Thereafter, continuation statements with respect to the Filed UCC-1 Financing Statements were not filed as required under the applicable Uniform Commercial Code to continue the effectiveness of the Filed UCC-1 Financing Statements, and the Filed UCC-1 Financing Statements lapsed and the Collateral Security Interest became unperfected.

NOW THEREFORE, , Assignor hereby certifies that (1) all of the Obligations previously secured by the Collateral Security Interest have been repaid and satisfied in full, and all commitments to lend by the Assignee to Assignor have been since terminated, and (2) the Filed UCC-1 Financing Statements have lapsed and the Collateral Security Interest has become unperfected. Assignor further causes this Notice to be filed and duly recorded with the United States Patent and Trademark Office.


