SECURITY INTEREST TERMINATION

WHEREAS, each of Amerifit Brands, Inc., Amerifit, Inc. and Amerifit Pharma, Inc. (the "Grantors"), granted a security interest to CapitalSource Finance LLC, (the "Secured Party") in those certain trademarks set forth on Exhibit A hereto, (the "Marks"), pursuant to a certain Intellectual Property Security Agreement (the "Agreement") which was filed at the United States Patent and Trademark Office on April 22, 2005 and recorded on Reel 3104 and beginning on Frame 0186; and

WHEREAS, the security interests of the Secured Party in the Marks pursuant to the Agreement have been terminated.

NOW, THEREFORE, the Secured Party releases its security interest in, and reassigns to the Grantors, any and all interest it has, if any, in the Marks and declares as null and void all liens, security interests, and other claims, including any claim of ownership, of the Secured Party with respect to the Marks arising from the Agreement. The Secured Party agrees that, upon the request of the Grantors, and at the expense of the Grantors, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantors to effectuate the release of security interest contemplated herein.

IN WITNESS WHEREOF, the Secured Party and the Grantors have caused this Security Interest Termination to be executed as of this 12th day of February, 2010.






