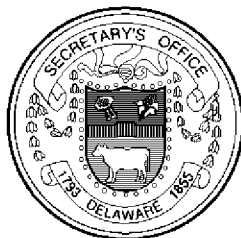

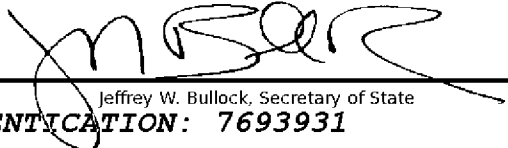

of the State of Delaware

NextAction Corporation (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware (the "DGCL"), DOES HEREBY CERTIFY:

FIRST: The Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on June 14, 2002 under the name NextAction Corporation.

SECOND: The following amendment to the Certificate of Incorporation has been duly adopted in accordance with the provisions of Sections 141, 228, and 242 of the DGCL:

Article FIRST of the Certificate of Incorporation is hereby deleted in its entirety and amended to read as follows:

"FIRST: The name of the Corporation is DataLogix, Inc. (hereinafter referred to as the "Corporation")"
