RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

Reference is made to the GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement"), effective as of November 13, 2006 made by CONEXANT SYSTEMS, INC., a Delaware corporation, located at 4000 MacArthur Boulevard, Newport Beach, California 92660 (the "Company"), in favor of THE BANK OF NEW YORK TRUST COMPANY, N.A., now held in favor of THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. (as successor to The Bank of New York Trust Company, N.A.), a national banking association, as Collateral Agent (the "Collateral Agent") for the holders of the notes (the "Holders") issued pursuant to the Indenture dated as of November 13, 2006 (as amended, supplemented or otherwise modified from time to time, the "Indenture") among the Company, the subsidiary guarantors party thereto and The Bank of New York Trust Company, N.A., now succeeded by The Bank of New York Mellon Trust Company, N.A. as trustee (the "Trustee"). Capitalized terms used herein and not otherwise defined have the meanings given to such terms in the Security Agreement (as defined below).

The Company and the Collateral Agent are parties to that certain Security Agreement dated as of November 13, 2006 (as the same may have been amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which the Company pledged and granted a continuing security interest in, and a right of setoff against, and agreed to assign, transfer and convey, upon written demand delivered to the Company upon the occurrence and during the continuance of an Event of Default without requiring further action by either party and to be effective upon such demand, all of the Company's right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Schedule A thereto, as modified from time to time) (collectively, the "Collateral"), to the Collateral Agent for the benefit of the Collateral Agent and the Holders to secure payment, performance and observance of the Obligations. With respect to the Trademarks identified on Schedule I attached hereto, this security interest has been further evidenced by the Agreement which was recorded with the Assignment Division of the United States Patent and Trademark Office at the reel/frame numbers set forth on Schedule I attached hereto.

Pursuant to Section 11.8 of the Indenture, the Collateral Agent hereby releases and relinquishes its security interest and any liens or mortgages that the Collateral Agent holds in the Collateral pursuant to the Agreement in accordance with Section 11.14 of the Security Agreement.

This release is executed by the Collateral Agent without representation or warranty of any kind.





FIRST: The Articles of Association of the Bank are hereby amended by amending Article FIRST thereof so that it shall read in its entirety as follows:

"FIRST. The title of this association shall be The Bank of New York Mellon Trust Company, National Association."

SECOND: This Amendment was duly adopted in accordance with the applicable provisions of Title 12, Section 30 of the United States Code, Title 12, Section 21a of the United States Code and Title 12, Section 5.42 of the Code of Federal Regulations.

THIRD: That this First Amendment to the Articles of Association shall be effective on July 1, 2008.
