SECOND AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

THIS AGREEMENT (this "<u>Agreement</u>"), dated as of March 1, 2010, is by and between each of the undersigned debtors (hereinafter collectively referred to as the "<u>Debtors</u>") and Wilmington Trust FSB, as administrative agent (the "<u>Administrative Agent</u>") for (a) the Lenders under the Credit Agreement (as defined below), having an address at 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402. The Administrative Agent and the Lenders herein collectively referred to from time to time as the "Secured Parties".

WITNESSETH:

WHEREAS, each Debtors is either the borrower or a guarantor under the terms of a Second Amended and Restated Credit Agreement dated as of the date hereof (as amended from time to time, the "Credit Agreement") among Affinity Group, Inc., a Delaware corporation (the "Borrower"), the guarantors party thereto (together with the Borrower, the "Credit Parties"), the Lenders party thereto and the Administrative Agent, pursuant to which the Lenders agreed, subject to the terms and conditions set forth therein, to make certain Term Loans to the Borrower; and

WHEREAS, the Credit Agreement amends and restates in its entirety the Amended and Restated Credit Agreement dated as of June 24, 2003 among Affinity Group, Inc., the Guarantors party thereto, the Lenders party thereto, Canadian Imperial Bank of Commerce, as Syndication Agent, General Electric Capital Corporation, as Documentation Agent, and Canadian Imperial Bank of Commerce, as administrative agent (as successor to Fleet National Bank), as heretofore amended, supplemented or otherwise modified (the "Existing Credit Agreement");

WHEREAS, the Grantors and the Administrative Agent (as successor to Fleet National Bank and Canadian Imperial Bank of Commerce) are party to that certain (i) Amended and Restated Security Agreement, dated as of June 24, 2003 (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Borrower, certain of its subsidiaries party thereto from time to time, as guarantors, and the Administrative Agent (as successor to Fleet National Bank and the Canadian Imperial Bank of Commerce), and (ii) Amended and Restated Trademark Security Agreement, dated as of June 24, 2003, among the Borrower, the other Grantors, and the Administrative Agent (as successor to Fleet National Bank and the Canadian Imperial Bank of Commerce) (the "Original Trademark Security Agreement");

WHEREAS, in order to induce the Lenders to enter into the Credit Agreement and the other Loan Documents, pursuant to the Security Agreement, each Grantor has granted to the Administrative Agent a security interest in and continuing lien on, all of such Grantor's right, title and interest in, to and under all Collateral, including the Intellectual Property (as defined below), in each case whether now owned or existing or hereafter acquired or arising and wherever located to secure the prompt and complete payment and performance in full when due, whether at stated maturity, by required prepayment, acceleration, demand or otherwise, of all Secured Obligations (as defined in the Security Agreement); and

WHEREAS, the obligations of the Secured Parties to enter into the Credit Agreement, and of the Secured Parties to make the Term Loans to the Borrower are subject to the condition, among others, that each Debtor shall execute and deliver this Agreement and grant the security interest hereinafter described; and

WHEREAS, each Debtor is the owner of the Intellectual Property (as defined herein) which on the schedules attached hereto is designated as being owned by such Debtor.

NOW THEREFORE, in consideration of the willingness of the Secured Parties to enter into the Credit Agreement and of the Secured Parties to agree, subject to the terms and conditions set forth therein, to make the Term Loans to the Borrower pursuant thereto, and for other good and valuable consideration, receipt of which is hereby acknowledged, it is hereby agreed, with the intent to be legally bound, as follows:

- 1. All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Credit Agreement. For the purposes of this Agreement, the following capitalized terms used herein shall have the following meanings:
- 1.1. The term "Trademarks" shall mean all trademarks, service marks, common law trademarks and trade names of each Debtor, or either of them, either owned by or assigned to such Debtor, including without limitation the registrations, applications, unregistered trademarks, and service marks set forth on Schedule 1.1 attached hereto, together with all federal and state trademark registrations and applications made by such Debtor, together with the sole and exclusive right to use, adapt, change, translate, add to and take from any or all of the foregoing; whether now owned or hereafter acquired, along with any and all (1) renewals of all of the foregoing, (2) income, royalties, damages and payments now due and hereafter due and/or payable with respect thereto, including without limitation, damages, claims and payments for past or future infringements thereof, (3) rights to sue for past, present and future infringements thereof, (4) foreign trademarks, trademark registrations, and trade name applications for any thereof, and any other rights corresponding thereto throughout the world, together with the entire goodwill of the business and products symbolized by the Trademarks of such Debtor, but specifically excluding all Intents to Use filed by any such Debtor.
- 1.2. The term "License Agreements" shall mean the entire right, title and interest of each Debtor in, to and under all exclusive and nonexclusive license agreements which relate to any or all of the Trademarks or Trade Secrets (as defined below), whether the Debtor is licensor or licensee, with respect to any such items owned by third parties; whether now owned or hereafter acquired and all payments or other proceeds therefrom, including without limitation the License Agreements set forth on Schedule 1.2 hereto.
- 1.3. The term "<u>Trade Secrets</u>" shall mean all ideas, trade secrets, inventions, products, processes, methods, concepts, techniques, formulas, plans and data, whether patentable or able, whether now owned or hereafter acquired, or as to which any such Debtor has any right or claim, and all proceeds and products thereof.

- 1.4. The security interest hereby granted shall secure the due and punctual payment and performance when due of the Secured Obligations (as defined in the Security Agreement) owed to the Secured Parties under the Credit Agreement
- 2. As security for the Secured Obligations described in Section 1.4 hereof, each Debtor hereby grants to the Administrative Agent for itself and for the benefit of the other Secured Parties a security interest in and lien on all of the intangible property of such Debtor, including without limitation the property described below, whether now owned or existing or hereafter acquired or arising, together with any and all additions thereto and replacements therefor and proceeds and products thereof (hereinafter referred to collectively as the "Intellectual Property"):
- (a) All right, title and interest in the Trademarks, License Agreements and Trade Secrets and all renewals thereof;
- (b) The entire goodwill of such Debtor's business and other general intangibles (including know-how, trade secrets, customer lists, proprietary information, inventions, domain names, methods, procedures and formulae) connected with the use of and symbolized by any Trademarks of such Debtor;
- (c) All of such Debtor's rights in respect of the Trademarks, License Agreements and Trade Secrets, including the right to sue for infringement thereof; and
- (d) All proceeds and products of any of the foregoing (including, without limitation, all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto), and all reissues, divisions, continuations, renewals, extensions, and continuations-in-part of any of the foregoing, all tangible property embodying any of the foregoing, and the right to sue for past, present or future infringements and all rights corresponding thereto.

Simultaneously with the grant of the security interest hereunder, each Debtor has granted to the Administrative Agent a security interest in all of its accounts receivable, inventory, equipment, websites and domain names, and general intangibles which comprise the goodwill of such Debtor, under the Security Agreement. It is the intent of each Debtor to grant the lien hereunder with a lien on the goodwill of such Debtor.

3. This Agreement is intended to create a security interest in the Intellectual Property for collateral purposes only and not as a current assignment. Unless and until an Event of Default occurs under the Credit Agreement, each Debtor shall continue to have the sole right to (i) own and utilize such Intellectual Property in the ordinary course of business, and (ii) except as otherwise provided herein, control the nature and quality of the goods sold and the services rendered under the Intellectual Property, provided that the rights under (i) and (ii) are exercised in the ordinary course of business and consistent with past practice. Each Debtor covenants and agrees that until all of the Secured Obligations are paid in full in accordance with the terms of the Credit Agreement, such Debtor will not enter into any agreement which is inconsistent with or which may materially or adversely affect such Debtor's Secured Obligations or Intellectual Property, or the Secured Parties' rights under this Agreement.

- 4. Each Debtor represents and warrants to the Secured Parties as follows:
- (a) Each Debtor is, and, as to the Intellectual Property acquired by it from time to time after the date hereof, such Debtor will be, except as indicated on the schedules attached hereto, the sole, true and lawful exclusive owner or, as applicable, licensee of all Intellectual Property and the interests herein granted;
- (b) The Intellectual Property is free from all liens, security interests, claims and encumbrances except those in favor of the Secured Parties or those disclosed in or permitted by the Credit Agreement;
- (c) Except as granted to the Secured Parties or as disclosed in or permitted by the Credit Agreement, the Debtor has granted no other security interests in its Intellectual Property that are currently outstanding; and
- (d) Except as disclosed on <u>Schedule 1.1</u> of this Agreement, all of the Trademarks listed thereon have been duly and properly filed or registered with the United States Patent and Trademark Office and all of the Trademarks listed on such schedules are owned of record or beneficially by such Debtor;
- (e) The Trademarks and other Intellectual Property of each Debtor continue to be used by such Debtor and have not been abandoned.
- (f) No claim of infringement has been brought or, to the best of each Debtor's knowledge, is threatened against such Debtor with respect to any of the Intellectual Property;
 - 5. Each Debtor hereby covenants to the Secured Parties as follows:
- (a) No Debtor will sell, license, transfer, pledge, assign or otherwise dispose of any Intellectual Property or any interest therein nor will any Debtor create, incur or permit to exist any lien, charge, encumbrance or security interest with respect to any Intellectual Property except as to nonexclusive licenses granted in connection with marketing or administration of member or other benefit programs engaged in by such Debtor and as permitted under the Credit Agreement or otherwise consented to in writing by the Secured Parties, it being expressly understood that no Debtor shall sell or otherwise dispose of all or substantially all of the Intellectual Property without the written consent of each of the Secured Parties;
- (b) The Debtor will furnish to the Administrative Agent, from time to time, statements and schedules further identifying and describing the Intellectual Property and such other reports and information in connection with the Intellectual Property as the Administrative Agent may reasonably request;
- (c) The Debtor will promptly notify the Administrative Agent, in writing, (i) that any material item of the Intellectual Property may have become abandoned (notwithstanding the prohibition set forth in subsection (i) below), (ii) of any adverse claim (of infringement or otherwise), determination or any development (including, without limitation, the institution of any proceeding in the United States Patent and Trademark Office or any court) regarding any material item of the Intellectual Property, and (iii) of any default, or any occurrence which with

the giving of notice or the passing of time, or both, would constitute a default, under any of the License Agreements;

- (d) The Debtor will promptly pay when due all taxes, levies, maintenance fees, charges, assessments, license fees and similar taxes or impositions payable in respect of the Intellectual Property and other governmental charges with respect to the Intellectual Property;
- (e) Upon obtaining knowledge thereof, the Debtor will promptly notify the Administrative Agent of any event which may be expected to cause a material loss or diminution in value of all or any part of its Intellectual Property or the ability of the Debtors or the Administrative Agent to dispose of the Intellectual Property or any portion thereof or the rights and remedies of the Administrative Agent or the Secured Parties in relation thereto including, without limitation, a levy or threat of levy or any legal process against the Intellectual Property or any portion thereof;
- (f) The Debtor will use consistent standards of quality in its manufacture, publication and sale of products or services sold under the Intellectual Property;
- (g) The Debtor will not use any item of the Intellectual Property in violation of any statute, ordinance or other provision of law, the violation of which could have a material adverse effect on the business of the Debtor;
- (h) The Debtor will not take any action in connection with the Intellectual Property that would materially impair the value of the interest or rights thereunder of the Debtor, the Administrative Agent or the Secured Parties;
- (i) The Debtor will not abandon any of the Intellectual Property or any registration or application therefor without the prior written consent of the Secured Parties and will maintain and protect all registrations of the Trademarks by timely filing, when required by law, all declarations of continued use, incontestability and renewal, except for the Intellectual Property no longer used in its business; and
- (j) The Debtor will diligently pursue any infringement claims it may now or hereafter have with respect to the Intellectual Property.
- 6. With respect to any Trademark which any Debtor subsequently registers with the United States Patent and Trademark Office or with any state authority, or an application is filed therefor, or any Debtor shall obtain rights to any new Intellectual Property, such Debtor undertakes to promptly provide the Administrative Agent with written notice thereof and evidence of such application and/or registration to the Administrative Agent and its counsel. Those Trademarks so registered by any Debtor in the future are deemed to be described in Schedules 1.1 and 1.2 hereto, and the Administrative Agent may record this Agreement against each such item and in connection with any such changes. Such Debtor shall cooperate with the Administrative Agent in modifying Schedules 1.1 and 1.2. Each Debtor agrees that it will join with the Administrative Agent to file and refile, such financing statements, continuation statements and other documents (including, without limitation, this Agreement), in such offices (including, without limitation, the United States Patent and Trademark Office and appropriate state

trademark offices), as the Administrative Agent may reasonably deem necessary or appropriate, wherever required or permitted by law in order to perfect and preserve the rights and interests granted to the Administrative Agent for the benefit of the Secured Parties hereunder. Each Debtor hereby authorizes the Administrative Agent to file financing statements and amendments, relative to all or any part thereof, without the signature of such Debtor where permitted by law and agrees to do such further acts and things, and to execute and deliver to the Administrative Agent such additional assignments, agreements, powers and instruments, as the Administrative Agent may require to carry into effect the purposes of this Agreement or better to assure and confirm unto the Administrative Agent its respective rights, powers and remedies hereunder. Each Debtor shall, upon the request of the Administrative Agent, and hereby authorizes the Administrative Agent to, take any and all such actions as may be deemed necessary by the Administrative Agent to perfect and preserve the rights and interests granted to the Administrative Agent for the benefit of the Secured Parties with respect to the Intellectual Property wherever located. All of the foregoing shall be at the sole cost and expense of the Debtors. This Section is not intended to cover any Intent to Use filed by any Debtor.

- 7. The Debtors shall be in default under this Agreement upon the happening of any Event of Default, as defined in the Credit Agreement (herein called "Events of Default").
- 8. Upon the occurrence an during the continuation of any Event of Default, the Secured Parties shall have the following rights and remedies:
- (a) All rights and remedies provided by law, including, without limitation, those provided by the Uniform Commercial Code of The Commonwealth of Massachusetts, as amended, or other applicable law of Massachusetts or any other jurisdiction, state or federal;
 - (b) All rights and remedies provided in this Agreement; and
- (c) All rights and remedies provided in the Credit Agreement or in the Loan Documents, or in any other agreement, document or instrument pertaining to the Secured Obligations.

Any and all of the foregoing rights and remedies may be exercised by the Administrative Agent simultaneously or consecutively, against or in respect of any Debtor all of which rights and remedies shall, to the fullest extent permitted by law, be cumulative. The choice of one or more rights or remedies shall not be construed as a waiver or election barring other rights and remedies. Each Debtor hereby acknowledges and agrees that the Administrative Agent is not required to exercise all remedies and rights available to it equally with respect to all of the Intellectual Property and that the Administrative Agent may select less than all of the Intellectual Property with respect to which the remedies as determined by the Administrative Agent may be exercised. Each Debtor understands that the Intellectual Property may decline in value in the event that the business of the Debtor is not continued.

Upon the occurrence and during the continuance of any Event of Default, in addition to any rights obtaining under law and hereunder, the Administrative Agent shall have the right to sell, assign and transfer all or any part of any Debtor's respective right, title and interest in and to the Intellectual Property, and the goodwill of any Debtor's businesses and products symbolized

by and connected with the Intellectual Property. In the event of the occurrence of an Event of Default, each Debtor hereby authorizes and empowers the Administrative Agent to make, constitute and appoint any agent of the Administrative Agent as the Administrative Agent may select, in its exclusive discretion, as such Debtor's true and lawful attorney-in-fact, with the power to endorse such Debtor's name on all assignment documents, applications, documents, papers and instruments necessary for the Administrative Agent to use, grant, license or assign or otherwise transfer title in the Intellectual Property to any Person with any related goodwill. This power-of-attorney shall be irrevocable for the life of this Agreement.

- Notwithstanding any other provision of this Agreement, the rights of the parties 9. hereunder are subject to the provisions of the Credit Agreement and, solely with respect to the Intellectual Property of the Camping World Entities (the "Camping World IP"), the Camping World Intercreditor Agreement including the provisions thereof pertaining to the rights and responsibilities of the Administrative Agent. This Agreement shall be in addition to the Credit Agreement and the Camping World Intercreditor Agreement and all other present and future instruments, documents and agreements between any Debtor and the Administrative Agent, and it shall not be deemed to affect, modify or limit any of the same or any rights of the Administrative Agent thereunder. In the event that any provision of this Agreement is in conflict with the terms of the Credit Agreement or the Camping World Intercreditor Agreement, the Credit Agreement or the Camping World Intercreditor Agreement shall control. Unless the context shall otherwise clearly indicate, the terms "Secured Party" and "Secured Parties" as used herein shall be deemed to include the Administrative Agent acting on behalf of the Secured Parties pursuant to the Credit Agreement and the Camping World Intercreditor Agreement. The term "Administrative Agent" as used herein shall include Wilmington Trust FSB, or any other Person acting as Administrative Agent for the Secured Parties pursuant to the terms of the Credit Agreement and the Camping World Intercreditor Agreement.
- 10. Each Debtor will defend at its own cost and expense any action, claim or proceeding materially affecting the interest of the Administrative Agent in the Intellectual Property. Each Debtor will take all actions deemed reasonably necessary to enforce its rights in, and the validity of, the Intellectual Property.
- 11. This Agreement sets forth all of the promises, covenants, agreements, conditions and understandings among the parties hereto with respect to the subject matter hereof, and supersedes all prior and contemporaneous agreements and understandings, inducements or conditions, express or implied, oral or written, with respect thereto, except as contained or referred to in the Credit Agreement or herein. Except as provided in paragraph 6 hereof, this Agreement may not be amended, waived, discharged or terminated orally, but only by an instrument in writing signed by the party against whom enforcement of such amendment, waiver, discharge or termination is sought.
- 12. If any provisions of this Agreement shall for any reason be held to be invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision hereunder, but this Agreement shall be construed as if such invalid or unenforceable provision had never been contained herein.

- 13. No remedy or right herein conferred upon, or reserved to, the Administrative Agent is intended to be to the exclusion of any other remedy or right, but each and every such remedy or right shall be cumulative and shall be in addition to every other remedy or right given hereunder, and now or hereafter existing at law or in equity.
- 14. No delay or omission by the Administrative Agent to exercise any remedy or right accruing upon an Event of Default shall impair any such remedy or right, or shall be construed to be a waiver of any such Event of Default, or an acquiescence therein, nor shall it affect any subsequent Event of Default of the same or of a different nature.
- When all of the Secured Obligations have been paid in full and have been terminated and the Commitments of the Secured Parties to make any Loan under the Credit Agreement have terminated or expired, this Agreement and the security interest in the Intellectual Property created hereby shall terminate. In such event, the Administrative Agent agrees to execute appropriate releases of liens on the Intellectual Property upon the request of the Debtors and at the Debtors' expense. No waiver by the Administrative Agent or by any other holder of Secured Obligations of any default shall be effective unless in writing nor operate as a waiver of any other default or of the same default on a future occasion. In the event of a sale or assignment by any Secured Party of all or any of the Secured Obligations held by it in accordance with the provisions of the Credit Agreement, any such Secured Party may assign or transfer its respective rights and interest under this Agreement in whole or in part to the purchaser or purchasers of such Secured Obligations, whereupon such purchaser or purchasers shall become vested with all of the powers and rights of a Secured Party hereunder. Notwithstanding the provisions of this section 15, this Agreement shall continue to be effective or be reinstated, as the case may be, if at any time any amount received by the Administrative Agent in respect of the Secured Obligations is rescinded or must otherwise be restored or returned by any Secured Party upon the insolvency, bankruptcy, dissolution, liquidation or reorganization of any of the Credit Parties or the Holding Company or upon the appointment of any intervenor or conservator of, or trustee or similar official for, any Credit Party or any substantial part of any of their properties, or otherwise, all as though such payments had not been made.
- 16. This Agreement shall be binding upon the successors or assigns of each Debtor and shall inure to the benefit of and be enforceable by the successors or assigns of the Secured Parties.
- 17. Each Debtor will at its expense, execute, deliver, file and record (in such manner and form as the Administrative Agent may at any time require) any financing statements, any carbon, photographic or other reproduction of a financing statement or this Agreement (which shall be sufficient as a financing statement hereunder), any specific assignments or other documents that may be reasonably necessary or desirable, or that the Administrative Agent may request, in order to create, pursue, perfect or validate its interest in the Intellectual Property or to enable the Administrative Agent to exercise and enforce its rights hereunder with respect to any of the Intellectual Property. Without limiting the generality of the foregoing, each Debtor will execute and file such short form Assignments for Security with respect to the Trademarks as the Administrative Agent may request, such assignments to be in form and substance satisfactory to the Administrative Agent, but each such assignment shall be for security purposes only. To the

extent permitted by applicable law, the Administrative Agent is hereby appointed by each Debtor as its attorney-in-fact, irrevocably, to do any and all acts and things which the Administrative Agent may reasonably deem necessary to perfect and continue perfected the security interest hereby created including, without limitation, the execution on behalf of any Debtor of any financing or continuation statement with respect to the security interest created hereby.

- This Agreement, including the validity hereof and the rights and obligations of the 18. parties hereunder, shall be construed in accordance with and governed by the laws of The Commonwealth of Massachusetts. Each Debtor, to the extent that it may lawfully do so, hereby consents to service of process, and to be sued, in any state or federal court located in The Commonwealth of Massachusetts and consents to the nonexclusive jurisdiction of the courts of The Commonwealth of Massachusetts and the United States District Court for the District of Massachusetts, as well as to the jurisdiction of all courts to which an appeal may be taken from such courts, for the purpose of any suit, action or other proceeding arising out of any of its obligations hereunder or with respect to the transactions contemplated hereby, and expressly waives any and all objections it may have as to venue in any such courts. Each Debtor further agrees that a summons and complaint commencing an action or proceeding in any of such courts shall be properly served and shall confer personal jurisdiction if served personally or by certified mail to it in accordance with Section 20 hereof or as otherwise provided under the laws of The Commonwealth of Massachusetts. Nothing in this Agreement shall affect any right the Administrative Agent or any Secured Party may otherwise have to bring an action or proceeding relating to this Agreement against any Debtor or its properties in the courts of any jurisdiction. EACH DEBTOR AND EACH SECURED PARTY IRREVOCABLY WAIVES ALL RIGHT TO A TRIAL BY JURY IN ANY SUIT, ACTION OR OTHER PROCEEDING HEREAFTER INSTITUTED BY OR AGAINST SUCH DEBTOR OR SUCH SECURED PARTY IN OBLIGATIONS HEREUNDER OR THE **TRANSACTIONS** RESPECT OF ITS CONTEMPLATED HEREBY.
- Each Debtor hereby waives presentment, demand, notice, protest and, except as is otherwise provided herein or in the other Loan Documents, all other demands and notices in connection with this Agreement or the enforcement of the Secured Parities' rights hereunder or in connection with any Secured Obligations or any Intellectual Property; consents to and waives notice of the granting of renewals, extensions of time for payment or other indulgences to the other Debtors or to any account debtor in respect of any account receivable or to any other third party, or substitution, release or surrender of any Intellectual Property, the addition or release of persons primarily or secondarily liable on any Secured Obligation or on any account receivable or other Intellectual Property, the acceptance of partial payments on any Secured Obligation or on any account receivable or other Intellectual Property and/or the settlement or compromise thereof. No delay or omission on the part of the Administrative Agent or the Secured Parties in exercising any right hereunder shall operate as a waiver of such right or of any other right hereunder. Any waiver of any such right on any one occasion shall not be construed as a bar to or waiver of any such right on any future occasion. EACH DEBTOR FURTHER WAIVES ANY RIGHT THEY MAY HAVE UNDER THE LAWS OF THE COMMONWEALTH OF MASSACHUSETTS, UNDER THE LAWS OF ANY STATE IN WHICH ANY OF THE INTELLECTUAL PROPERTY MAY NOW OR HEREAFTER BE LOCATED OR WHICH MAY BE APPLICABLE TO ANY INTELLECTUAL PROPERTY, OR UNDER THE LAWS OF THE UNITED STATES OF AMERICA, TO NOTICE (OTHER THAN ANY

REQUIREMENT OF NOTICE PROVIDED HEREIN) OR TO A JUDICIAL HEARING PRIOR TO THE EXERCISE OF ANY RIGHT OR REMEDY PROVIDED BY THIS AGREEMENT TO THE ADMINISTRATIVE AGENT OR THE SECURED PARTIES AND WANES ITS RIGHTS, IF ANY, TO SET ASIDE OR INVALIDATE ANY SALE DULY CONSUMMATED IN ACCORDANCE WITH THE FOREGOING PROVISIONS HEREOF ON THE GROUNDS (IF SUCH BE THE CASE) THAT THE SALE WAS CONSUMMATED WITHOUT A PRIOR JUDICIAL HEARING. Each Debtor's waivers under this section have been made voluntarily, intelligently and knowingly and after such Debtor has been apprised and counseled by its attorneys as to the nature thereof and its possible alternative rights.

- 20. <u>Notices</u>. All notices, consents, approvals, elections and other communications hereunder shall be in writing (whether or not the other provisions of this Agreement expressly so provide) and shall be deemed to have been duly given if delivered in accordance with the terms of the Credit Agreement.
- 21. This Agreement is entitled to the benefits of any loan documents now or hereafter issued in connection with the indebtedness secured hereunder, including, without limitation, the Credit Agreement and any other Loan Documents which documents may be amended, modified or substituted without affecting the validity of this Agreement. To the extent that there are any inconsistencies between any term or provision herein and any term or provision in the Credit Agreement, the terms of the Credit Agreement shall control.
- 22. The proceeds of any sale or sales or other disposition of the Camping World IP, together with any other additional collateral security at the time received and held hereunder, shall be received and applied in accordance with the provisions of the Camping World Intercreditor Agreement.
- 23. This Agreement may be recorded by the Administrative Agent in the United States Patent and Trademark Office and any such other offices as the Administrative Agent may determine.
- 24. This Agreement may be executed in one or more counterparts, each of which shall constitute an original agreement, but all of which together shall constitute one and the same instrument.
- 25. This Agreement shall be deemed to amend, restate and replace the Original Trademark Security Agreement in its entirety. It is expressly understood and agreed by each of the parties hereto that this Agreement is in no way intended and shall not be deemed or construed to constitute a novation agreement. The Debtors acknowledge and agree that (i) each reference in the Loan Documents to the "Trademark Security Agreement" shall be a reference to this Agreement and (ii) with respect to matters prior to the date of this Agreement, all terms of the Original Trademark Security Agreement are ratified and confirmed.
