TRADEMARK ASSIGNMENT

WHEREAS, Game Time LLC, a New York limited liability company ("Game Time"), having an address at 181 Boyd Street, Montgomery, New York 12549, has entered into an Asset Purchase Agreement (hereby incorporated herein by reference in its entirety and referred to as the "Agreement") with Game Time Group LLC, a New York limited liability company, ("Group"), having an address at 1407 Broadway, Suite 400, New York, New York 10018, as of the Closing Date under the Agreement (capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms under the Agreement); and,


WHEREAS, the effect of the Agreement was to sell, transfer, convey, assign and deliver certain Purchased Assets of Game Time to Group. Such Purchased Assets include certain Intellectual Property Rights (as defined in Sections 1.2 and 4.13 of the Agreement); and,

NOW, THEREFORE, for good and valuable consideration set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Game Time conveys, transfers, assigns, delivers and contributes to Group all of Game Time's right, title, and interest of whatever kind in and to the trademarks and applications for trademarks listed in Appendix A (the "Marks"), together with (1) the goodwill of the business relating to all products upon which the Marks are used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to Game Time with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

AND, furthermore, Game Time covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Group full right, title, and interest in the Marks and further covenants and agrees with Group, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by it and that full right to convey the same as herein expressed is possessed by it, and such Marks are unencumbered by any lien, judgment, security interest or mortgage.


