**CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL  
PROPERTY COLLATERAL**

This CONFIRMATORY GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Agreement"), dated as of March 12, 2010 is made by CMI HOLDING COMPANY, INC., a Texas corporation (the "Debtor") in favor of CAPITAL SOUTHWEST CORPORATION, in its capacity as collateral agent and as pledgee, assignee, and secured party (in such capacities and together with any successors in such capacities, the "Collateral Agent") pursuant to the Note Purchase Agreements referenced and defined in that certain Security Agreement executed between the parties as of February 19, 2010 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement").

**WITNESSETH:**

WHEREAS, pursuant to the Security Agreement, the Debtor is granting to the Collateral Agent, for the benefit of the Secured Parties, a security interest in certain collateral, including certain pending and/or registered Patents, Trademarks, and Copyrights identified in Schedule A attached hereto and incorporated herein by reference (collectively, "Intellectual Property Collateral");

NOW, THEREFORE, in consideration of these premises and as collateral security for the payment and performance in full of all the Secured Obligations under the Security Agreement, the Debtor hereby agrees with the Collateral Agent, for the benefit of the Secured Parties, as follows:

SECTION 1. Definitions. Capitalized terms used but not defined herein shall have the meanings given to them in the Security Agreement.

SECTION 2. Grant of Security Interest. The Debtor hereby assigns and transfers to the Collateral Agent, and hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in the Intellectual Property Collateral now owned or at any time hereafter acquired by the Debtor or in which the Debtor now has or at any time in the future may acquire any right, title or interest (including, without limitation, those pending and/or registered Patents, Trademarks, and Copyrights listed on Schedule A) as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Debtor's obligations under the Security Agreement.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Debtor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the U.S. Copyright Office.


SECTION 4. Acknowledgment. The Debtor does hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the Intellectual Property Collateral are more fully set forth in the Security Agreement, the terms and conditions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF TEXAS.

SECTION 6. Counterparts. This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
