## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made this 12<sup>th</sup> day of February, 2010, by PNC Bank, National Association, as agent for the Lenders (in such capacity "Agent").

**WHEREAS**, reference is made to (i) that certain Trademark Security Agreement, dated as of June 12, 2006, by and among Geokinetics Inc. and certain of its subsidiaries (collectively, "June Grantors") and Agent (as amended to date, the "Geokinetics Trademark Security Agreement") and (ii) that certain Trademark Security Agreement, dated as of September 8, 2006, by and among Geokinetics International Holdings, Inc. (f/k/a Grant Geophysical Inc.) and certain of its affiliates (collectively, the "September Grantors", and together with the June Grantors, collectively the "Grantors") and Agent (as amended to date, the "Grant Trademark Security Agreement", and together with the Geokinetics Trademark Security Agreement, each individually a "Trademark Security Agreement" and collectively the "Trademark Security Agreements").

**WHEREAS**, in connection with each Trademark Security Agreement, the applicable Grantors granted Agent, for the benefit of the Lenders (as defined in the applicable Trademark Security Agreement), a continuing security interest in all of the right, title and interest of Grantors in and to the trademark collateral identified therein (the "Trademark Collateral").

**WHEREAS**, the Geokinetics Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 16, 2006, at Reel 003331, Frame 0693, and the Grant Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 5, 2007, at Reel 003574 Frame 0328.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby irrevocably and forever releases, terminates, re-

assigns and discharges any and all of its security interests in and to the Trademark Collateral including, without limitation, the Trademarks described in the schedules attached to the Trademark Security Agreement and attached as Exhibit A hereto. Further, Agent understands and agrees that that this Release may be recorded by or for the Grantors with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Agent also agrees, solely at the expense of the Grantors, to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
