
TRADEMARK ASSIGNMENT CONFIRMATION



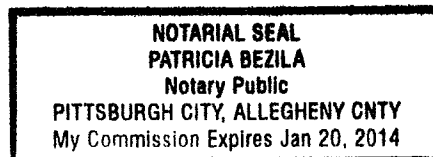
