
RELEASE OF SECURITY INTEREST IN TRADEMARKS

FOR VALUE RECEIVED, the undersigned, **THE CIT GROUP/BUSINESS CREDIT, INC.**, a New York corporation ("Assignor"), does hereby sell, assign, transfer and convey to **GEO SPECIALTY CHEMICALS, INC.**, an Ohio corporation ("Assignee"), **without any representation or warranty by, or recourse to**, Assignor, all right, title and interest of Assignor in and to the trademarks and trademark applications listed on Schedule A attached hereto, arising under (a) a certain Trademark Security Agreement dated March 31, 2005, between Assignee and Assignor recorded in the United States Patent and Trademark Office ("USPTO") on April 4, 2005, at Reel No. 3058, Frame 726; (b) a certain Notice of Grant of Security Interest in Trademarks dated November 2, 2005, between Assignee and Assignor recorded in the USPTO on January 18, 2006, at Reel No. 3229, Frame 579; and (c) a certain Notice of Grant of Security Interest in Trademarks dated February 13, 2007, between Assignee and Assignor recorded in the USPTO on February 22, 2007, at Reel No. 3486, Frame 51, and on March 19, 2007, at Reel No. 3502, Frame 477 (all of the foregoing, together with any amendments thereto, are collectively referred to herein as the "Trademark Security Agreement"), together with the goodwill of the business symbolized by the marks.

This Assignment intended to operate as a release of all liens and security interests conveyed by Assignee to Assignor pursuant to the terms of the Trademark Security Agreement, and to reassign to Assignee all of Assignor's right, title, and interest acquired pursuant to the terms of the Trademark Security Agreement.
