## CONFIRMATORY GRANT OF TRADEMARK SECURITY INTEREST

WHEREAS, pursuant to the Agreements, Borrower has granted to Agent for its benefit and for the ratable benefit of Lenders a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.



Additionally, all such terms and provisions of the Agreements are herein incorporated by reference and in the event that this Confirmatory Grant of Trademark Security Interest is deemed to conflict with the Agreements, the terms of the Agreements shall govern.




