## TRADEMARK SECURITY AGREEMENT

Trademark Security Agreement (this "Agreement") dated as of March 31, 2010 by and between DIAMOND FOODS, INC., a Delaware corporation (the "Grantor"), having its chief executive office at 600 Montgomery Street, 17<sup>th</sup> Floor, San Francisco, California, 94111, and BANK OF AMERICA, N.A., as Administrative Agent (the "Administrative Agent"), with offices at 2001 Clayton Road, 2<sup>nd</sup> Floor, Concord, California 94520, for the ratable benefit of the Secured Parties as defined in that certain Credit Agreement, dated as of February 25, 2010 (as amended, restated, supplemented or otherwise modified, the "Credit Agreement"), among the Grantor, the banks and other financial institutions from time to time party thereto and the Administrative Agent.

This Agreement is executed pursuant to the terms of a Collateral Agreement dated as of February 25, 2010 among the Grantor, certain of its Subsidiaries party thereto and the Administrative Agent for the ratable benefit of the Secured Parties (as amended, restated, supplemented or otherwise modified, the "Collateral Agreement"). Capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Collateral Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) each Trademark and all of the associated goodwill connected with the use of, and symbolized by, each Trademark of the Grantor, including, without limitation, each Trademark described on Schedule A;
- (ii) all claims by the Grantor against third parties for (a) past, present or future infringement or dilution of any Trademark, including, without limitation, any Trademark described on Schedule A or (b) injury to the goodwill associated with any Trademark; and
- (iii) all products and proceeds of the foregoing.

The rights and remedies of the Administrative Agent, on behalf of the Secured Parties, with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern.

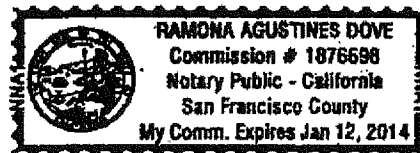
