**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT (this "Trademark Assignment") is made by General Chemical Performance Products LLC, a corporation organized under the laws of Delaware ("General Chemical"), and GenTek Holding, LLC, a limited liability company organized under the laws of Delaware (together with General Chemical, "Assignor") to KMG Electronic Chemicals, Inc., a corporation organized under the laws of Texas ("Assignee").

**RECITALS**

A. General Chemical and Assignee are parties to a certain Asset Purchase Agreement, dated as of February 25, 2010, by and among General Chemical, Assignee and General Chemical Holding Company, a corporation organized under the laws of Delaware (the "Purchase Agreement").

B. Pursuant to the Purchase Agreement, General Chemical agrees to transfer or cause to be transferred to Assignee the trademarks set forth on Schedule A hereto, along with all goodwill associated therewith (the "Assigned Trademarks").

C. Assignee wishes to acquire, and Assignor wishes to transfer to Assignee, Assignor's entire right, title and interest in and to the Assigned Trademarks.

D. Assignee and Assignor desire to record the assignments set forth in this Trademark Assignment.

**AGREEMENT**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee Assignor's entire right, title and interest in and to the Assigned Trademarks, including, but not limited to, all benefits, privileges, causes of action, and remedies relating to such Assigned Trademarks. The foregoing includes, and Assignor hereby assigns, transfers and conveys to Assignee, all goodwill symbolized by the Assigned Trademarks together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Assigned Trademarks, with the right to sue for, and collect the same.

Assignee will hold all right, title and interest in and to the Assigned Trademarks as fully and exclusively as it would have been held and enjoyed by Assignor had the assignment under this Agreement not been made. Assignee accepts such assignment, and assumes (and shall pay, perform and discharge when due) all obligations with respect to the Assigned Trademarks from and after the date of this Trademark Assignment.

Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue trademarks and applications and registrations therefor, to issue the same to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Assignor hereby covenants and agrees, at Assignee's reimbursement of Assignor's out-of-pocket expenses, that it will communicate to Assignee, its successors, legal representatives and assigns, any facts known to it pertaining to the Assigned Trademarks and take such further action and execute such additional documents as Assignee, or its successors, legal representatives, and assigns may reasonably request, in order to carry out and fulfill the purposes and intent of this Trademark Assignment to obtain and enforce proper protection for the Assigned Trademarks, or any rights related thereto. Assignor and any affiliates shall not contest, nor assist any third party to contest, the scope of Assignee's ownership of the Assigned Trademarks, including in any claim, action, arbitration, suit, inquiry or proceeding.

This Agreement may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. This Agreement shall be governed by and construed in accordance with the laws of the State of New York (without regard to the principles of conflicts of laws thereof).
