## TRADEMARK ASSIGNMENT

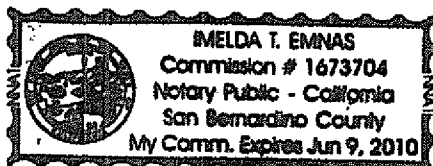
