## Trademark Assignment Agreement

This Trademark Assignment Agreement (the "Agreement") is made and effective as of 22 March, 2010, by and between APP (TM) Ltd., a Mauritius corporation ("Assignor"), and PT. Purinusa Ekapersada, an Indonesia limited liability company, and PT. Pabrik Kertas Tjiwi Kimia Tbk., an Indonesia public limited liability company (together the "Assignee").

### RECITALS

WHEREAS, Assignor has used the mark INSPIRA in interstate commerce in the United States of America in connection with paper, namely bond paper, carbon paper, copy paper, computer paper, crepe paper, gift wrapping paper, loose leaf paper, laminated paper, metallic gift wrapping paper, paper for packing, printing paper, tracing paper, wrapping paper, paper tissue, paper towels, paper containers, paper cartons, paper refuse bags, paper tags and paper tape; cardboard, namely, cartons, boxes, containers, cardboard floor display units for merchandising products, and cardboard mailing tubes; printed matter, namely, price tags, price tickets, and printed forms; bookbinding tape and bookbinding wire; photo albums; stationery; adhesives for stationery or household purposes; artists' materials, namely, art pads, art paper, and paint brushes; office requisites, namely, pens, paper dictionaries, document file racks, document file trays, document holders, pen or pencil holders, holders for desk accessories, notepads, notebooks, notecards, note paper, paper clips, office and label printing machine ribbons, envelopes, folders, photocopy paper and ink jet paper; playing cards; printing type; and printing blocks since at least as early as April 27, 2001, and owns the associated U.S. Trademark Registration No. 2834834 and the goodwill attaching thereto ("the Trademark"); and

WHEREAS, Assignee desires to acquire all of Assignor's right, title and interest in and to the Trademark, and the registration therefor, together with the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark.

### TERMS

1. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee, effective as of the date of this Agreement, all its right, title and interest in and to the Trademark, together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, and all causes of action and claims based on past actions or infringement related to the Trademark, along with any right to sue and recover for damages and profits.
2. The Assignor hereby guarantees the Assignee that all rights assigned hereto are truly owned by the Assignor itself, and they are not in disputes and are free from any claims, attachment, and are not being mortgaged from other party whomsoever.



In the event such amicable settlement is not reached, all disputes and controversies arising from this Letter of Assignment shall be finally settled under the Central Jakarta District Court.



5. This Agreement may be executed in counterparts with the same effect as if the parties had signed the same document. All counterparts shall be construed together and shall constitute one agreement.


