**NOTICE OF CHANGE OF ADMINISTRATIVE AGENT -
ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Studio IP Holdings, LLC, a Delaware limited liability company, OP Holdings LLC, a Delaware limited liability company, Official-Pillowtex LLC, a Delaware limited liability company and Mossimo Holdings LLC, a Delaware limited liability company (collectively, "Grantors"), own all right, title and interest in and to the trademark registrations and applications listed in Schedule A hereto (the "Trademarks");

WHEREAS, pursuant to the Amended and Restated Credit Agreement dated as of May 2, 2007 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Iconix Brand Group, Inc. a Delaware corporation ("Borrower"), the several banks and other financial institutions or entities from time to time parties thereto, Lehman Brothers Inc., and Lehman Commercial Paper Inc., a New York corporation, with an address at 745 Seventh Avenue, New York, NY 10019, as Administrative Agent for the Lenders, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Borrower and certain of its subsidiaries, including the Grantors, had executed and delivered a Guarantee and Collateral Agreement, dated as of March 30, 2007, in favor of Lehman Commercial Paper Inc., as Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors pledged and granted to Lehman Commercial Paper Inc., as Administrative Agent for the Lenders, a continuing security interest in all Intellectual Property, including the Trademarks, on terms and conditions set out in the Guarantee and Collateral Agreement;

WHEREAS, the security interest in the Trademarks granted to Lehman Commercial Paper Inc. was recorded in the United States Patent and Trademark Office at Reel 3526 Frame 0098 on April 20, 2007; Reel 3526 Frame 0072 on April 20, 2007; Reel 3678 Frame 0050 on December 14, 2007; Reel 3678 Frame 0174 on December 14, 2007; Reel 3689 Frame 0111 on January 3, 2008; and Reel 3872 Frame 0580 on October 20, 2008; and

WHEREAS, Borrower and each Grantor have entered into an Amendment, Resignation, Waiver, Consent and Appointment Agreement dated as of February 24, 2010 (as amended or otherwise modified from time to time, the "Amendment Agreement") whereby Lehman Commercial Paper Inc. resigned as Administrative Agent and was replaced by Barclays Bank PLC, a public liability company with an address at 745 Seventh

Avenue, New York, NY 10019, as successor Administrative Agent for the Lenders under the Credit Agreement, the Guarantee and Collateral Agreement and other Loan Documents;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each party, the parties hereby agree and confirm that:

1. Lehman Commercial Paper Inc. has ceased to be the Administrative Agent for the Lenders under the Credit Agreement, the Guarantee and Collateral Agreement and other Loan Documents; and
2. Barclays Bank PLC is now the Administrative Agent for the Lenders under the Credit Agreement, the Guarantee and Collateral Agreement and other Loan Documents.

All other terms and conditions are more fully set out in the Amendment Agreement. Unless otherwise defined herein or the context otherwise requires, the terms used in this agreement shall have the meanings provided or provided by reference in the Amendment Agreement or other Loan Documents.
