

## ASSIGNMENT AGREEMENT

This Assignment Agreement is made and entered into as of this \_\_\_\_ day of April, 2010, between JLG OmniQuip, Inc., a Delaware corporation, having a place of business at 13712 Crayton Boulevard, Hagerstown, Maryland 21742 (formerly located at 13224 Fountainhead Plaza, Hagerstown, Maryland 271742) ("OmniQuip") and JLG Industries, Inc., a Pennsylvania corporation, having a place of business at 1 JLG Drive, McConnellsburg, Pennsylvania 17233 ("JLG").

WHEREAS, OmniQuip is the owner of the trademarks and registrations thereof as set forth in Schedule A attached hereto and made a part hereof (hereafter the "Trademarks") and the patents and inventions embodied therein set forth in Schedule B attached hereto and made a part hereof (hereafter the "Patents");

WHEREAS, JLG is desirous of acquiring (a) all of OmniQuip's rights, title and interest and to all of the Trademarks, including the registrations thereof, together with the goodwill of the business symbolized by the Trademarks being assigned, and (b) all of OmniQuip's interests in the Patents;

WHEREAS, OmniQuip has agreed to assign the Trademarks and Patents to JLG and JLG hereby accepts said assignment.

NOW, THEREFORE, in consideration of the mutual promises and covenants made herein, the sum of \$[redacted] and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

(A) OmniQuip does hereby assign, transfer and convey unto JLG, its successors and assigns (i) all right, title, and interest in and to the Trademarks, including without limitation all goodwill of the business symbolized by the Trademarks, and all applicable registrations thereof, and (ii) all right, title and interest in and to the Patents, including without limitation all resulting patents and applications therefore and the full and exclusive right to the inventions covered by said Patents, and to the said Patents and to all subsequent applications based thereon including any and all continuations, divisions, reissues, and substitutes of said patents and application therefor, together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States of America adheres, and OmniQuip hereby authorizes and requests the Commissioner of Patents and Trademarks to issue said Patents to JLG, for its interest as assignee, its successors, assigns, and legal representatives

(B) OmniQuip does also hereby sell, assign, transfer and convey unto JLG, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the Trademarks and Patents, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

(C) OmniQuip hereby assumes all liabilities and obligations in connection with the assignment of the Trademarks and Patents, described in Paragraph (A) hereof, except as otherwise agreed in writing by the parties.

(D) OmniQuip agrees to execute and deliver at the request of JLG, all papers, documents, instruments and assignments, and to perform any other reasonable acts, at OmniQuip's sole cost and expense, that (1) JLG may require in order to vest all of OmniQuip's rights, title and interest in and to the Trademarks and Patents in JLG; (2) may be required in countries foreign to the United States to record JLG as the owner of the Trademarks and Patents herein assigned; and (3) JLG may require in any legal action that JLG may take regarding the protection of the rights of JLG in the Trademarks and Patents. The parties acknowledge the possible need or appropriateness in certain registration offices for separate assignments relating solely to a specific trademark on record in such registration offices. Accordingly, without limitation, OmniQuip agrees to execute said assignments upon request of JLG, in connection with separate assignments of trademarks.

(E) Omniquip further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country foreign to the United States, whose duty it is to record trademark registrations, patents and title thereto, to record the Trademarks, Patents and title thereto as the property of JLG, its successors, assigns and legal representatives in accordance with the terms of this instrument.

(F) This Assignment Agreement shall be governed by and construed in accordance with the laws of the State of Pennsylvania, without reference to its conflicts of law principles.


