TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of 4 May, 2010 (the "Termination and Release"), is made from Credit Suisse AG, Sydney Branch, having a principal place of business at Level 41, 101 Collins Street, Melbourne, Victoria 3000, Australia, as facility agent and security agent (the "Security Agent") for itself and certain banks and financial institutions (the "Lenders") that are parties to the Facility Agreement (as defined below), to BRPP, LLC, a North Carolina limited liability company having a principal place of business at One West Pack Square, Suite 1100, Asheville, North Carolina 28802 (the "Grantor"). Capitalized terms used herein without definition are used as defined in the Multi-Option Facility Agreement dated December 18, 2006, among Evergreen Packaging Inc., Carter Hold Harvey Limited, Carter Holt Harvey Finance Australia Pty Limited, the lenders from time to time party thereto and the Security Agent (as amended, supplemented or otherwise modified from time to time, the "Facility Agreement") or the Collateral Agreement (as defined below).

WITNESSETH:

WHEREAS, pursuant to the U.S. Collateral Agreement, dated as of December 14, 2007 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), made by the Grantor and the other Grantors (as defined therein) in favor of the Security Agent, a security interest (the "Security Interest") was granted by the Grantor to the Security Agent in certain Trademarks (as defined below);

WHEREAS, in connection with Supplement No. 2 to the Collateral Agreement, dated as of December 14, 2007, the parties entered into a Patent and Trademark Security Agreement, effective as of December 14, 2007, which was recorded in the Trademark Division of the United States Patent and Trademark Office on December 31, 2007, at Reel 3687, Frame 0121; and

WHEREAS, the Security Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Security Agent hereby states as follows:

1. <u>Trademarks</u>. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest in or to all of the Trademarks, whether owned by the

Grantor as of the date of the Collateral Agreement or acquired by the Grantor thereafter, but prior to the date hereof, including those listed on <u>Schedule I</u>.

- 2. Release of Security Interest. The Security Agent hereby unconditionally and irrevocably terminates, releases and discharges its Security Interest in the Trademarks, and any right, title or interest of the Security Agent in such Trademarks shall hereby cease and become void.
- 3. <u>Further Assurances</u>. The Security Agent shall execute and deliver to the Grantor all further releases and other documents (including without limitation Uniform Commercial Code termination statements), and take all other actions necessary or reasonably desirable for the release of the Security Interest.
