RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of March 3, 2010 granted by CITICORP NORTH AMERICA, INC., in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the “Collateral Agent”) in favor of JDA Software Group, Inc., JDA Software, Inc., JDA Worldwide, Inc., Stanley Acquisition Corp., Manugistics Group, Inc., Manugistics, Inc., Manugistics Holdings Delaware, Inc., Manugistics Holdings Delaware II, Inc., Manugistics Services, Inc. and Manugistics California, Inc. (the “Pledgors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of July 5, 2006 between the Pledgors and the Collateral Agent (the “Security Agreement”; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Pledgors granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the Trademarks including, without limitation, the Trademark registrations and applications set forth on Schedule I hereto together with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS the Security Agreement relating to the Trademarks has been recorded with the Assignments Division of the U.S. Trademark and Trademark Office on October 5, 2006 at Reel 3403 and Frame 0183; and

WHEREAS the Pledgors have paid all of their outstanding indebtedness under the Credit Agreement which is secured by the Security Agreement and have requested that the Collateral Agent release its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Pledgors. The Collateral Agent shall take all further actions, and provide to the Pledgors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to more fully and effectively effectuate the purposes of this Release.


This Release shall be construed in accordance with and governed by the law of the State of New York.
