## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

(United States of America)

May 19, 2010

WHEREAS, Charlotte Russe Merchandising, Inc. (the “Grantor”) had granted to Bank of America, N.A. (the “Secured Party”), a security interest (the “Security Interest”) in the Grantor’s trademarks and trademark applications (collectively, the “Trademarks”) and the goodwill associated therewith pursuant to a certain Trademark Security Agreement dated June 24, 2005 (the “Agreement”), which was filed at the United States Patent and Trademark Office on October 27, 2005 and recorded on Reel 3183, Frame 0008; and

WHEREAS, the Grantor and the Secured Party, among others, have agreed to enter into certain amendments (collectively, the “Amendment”) to the financing arrangement (the “Financing Arrangement”) among the Grantor, certain affiliates of the Grantor and the Secured Party; and

WHEREAS, in connection with the Amendment, the Secured Party has agreed, among other things, to release its Security Interest in the Trademarks and the goodwill associated therewith.

NOW, THEREFORE, the Secured Party releases, discharges and terminates its security interest in, and reassigns to the Grantor, any and all interest in the Trademarks, including, without limitation, those listed on Schedule A attached hereto, together with the goodwill associated therewith. The Secured Party agrees that, upon request of the Grantor or any successor-in-interest or assignee thereof, and at the Grantor’s expense, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein. Nothing contained herein shall be deemed to release the Secured Party’s security interest in any other collateral held by the Secured Party as security for the Liabilities (as defined in the Amendment), which security interest remains in full force and effect.
