**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of May 11, 2010, is made by CITICORP TRUSTEE COMPANY LIMITED, as Security Trustee (the "Security Trustee"), pursuant to the termination of the Senior Facilities Agreement, dated as of April 27, 2006 and amended and restated on May 9, 2006 by and among Elmira 1 B.V. (the "Parent") and certain of its Subsidiaries, including Tommy Hilfiger Licensing LLC (the "Grantor") and the Security Trustee (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Senior Facilities Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Senior Facilities Agreement.

WITNESSETH

WHEREAS, the Parent and certain of its Subsidiaries (including the Grantor) entered into a Senior Facilities Agreement with the Security Trustee.

WHEREAS, the Parent and certain of its Subsidiaries (including the Grantor) entered into a Mezzanine Facility Agreement dated April 28, 2006 and amended and restated on May 9, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time), the "Mezzanine Facility Agreement") with Citigroup Global Markets Limited, Credit Suisse, London Branch, FB Acquisition Finance Holding B.V. as Arrangers, Credit Suisse, London Branch, as Agent, the Security Trustee on behalf of the Secured Parties and the Lenders named therein (each as defined therein).

WHEREAS, the Parent and certain of its Subsidiaries (including the Grantor) entered into an Intercreditor Agreement dated May 9, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time) with, among others, Citibank International plc as Senior Facility Agent, Credit Suisse, London Branch, as Mezzanine Facility Agent, the Security Trustee and the Lenders (each as defined therein).

WHEREAS, in connection with the Senior Facilities Agreement and the Mezzanine Facility Agreement, the Grantor executed and delivered that certain Security Agreement dated May 24, 2006 made by the Grantor and others to the Security Trustee (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Terms defined in the Security Agreement and not otherwise defined herein are used herein as defined in the Security Agreement.

WHEREAS, under the terms of the Security Agreement, the Grantor granted, to the Security Trustee, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, including Trademark Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Intellectual Property Security Agreement dated August 14, 2006 and recorded with the U.S.

Patent and Trademark Office on August 21, 2006 at Reel/Frame No. 3373/0642 pursuant to which the Grantor granted to the Security Trustee, for the ratable benefit of the Secured Parties a security interest in all of the Grantor's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Trademark Collateral");

WHEREAS the Grantor has satisfied all of its obligations under the Senior Facilities Agreement, Mezzanine Facility Agreement, Intercreditor Agreement and the Security Agreement, therefore, the Intellectual Property Security Agreement has been terminated.


NOW, THEREFORE, in consideration of the foregoing, the Security Trustee hereby agrees as follows:

The Security Trustee, on behalf of itself and the other Secured Parties, hereby unconditionally and irrevocably releases unto the Grantor, all of its security interest in, and mortgage on, all rights, title and interests in and relating to the Trademark Collateral, including the trademark and service mark registrations listed on Schedule I attached hereto and incorporated herein by reference (collectively, the "Released Collateral").

The Security Trustee authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Security Trustee's Lien upon and security interest in the Trademark Collateral by the Grantor or any persons authorized or designated by the Grantor, and any such recordation or filing shall be deemed to have been authorized by the Security Trustee.

IN WITNESS WHEREOF, the Security Trustee has executed this Release as of the date first set forth above.
