TRADEMARK ASSIGNMENT

This Assignment is made by and between Fire Rated Product Specialties Corp., a Minnesota corporation, formerly known as Cubicles Plus, Inc., having a business address of 901 North 3rd Street, Suite 130, Minneapolis, MN 55401 (the "Assignor"), and E.Z. WHEREAS, the Assignee desires to acquire the Mark together with the goodwill of the business symbolized by the Mark, and to enjoy the protection of any registrations that have or shall issue in connection with the Mark.

NOW, THEREFORE, pursuant to the terms of the Agreement, Plan of Separation, and Mutual Release by and among the Assignor, Happy Moselle, Doug Mintz, and John Feges dated December 21, 2009, and for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Assignor does hereby assign, transfer, and sell unto the Assignee, its successors, and assigns all right, title, and interest in and to the Mark together with the goodwill of the business symbolized by the Mark, and all registrations that have or shall issue in connection with the Mark, including any applications pending for registration of the Mark. The Assignor further sells, assigns, and transfers unto the Assignee its entire right, title, and interest in and to any and all causes of action and rights of recovery for past infringement of the Mark.

This Assignment shall be binding upon the successors and assigns of the Assignor and shall inure to the benefit of the successors and assigns of the Assignee.
