To the extent that any of the Marks are trademark applications filed on an intent-to-use basis for which there has not yet been a filing of a Statement of Use or an Amendment to Allege Use, the

Assignor and Assignee agree and confirm that the assignment and transfer thereof is to a successor to the applicable portion of the business of the Assignor, and such business is ongoing and existing.


