**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of July 14, 2010 by HARRIS N.A., successor to Harris Trust and Savings Bank ("**Releasing Party**").

**WITNESSETH:**

WHEREAS, the Releasing Party and Queen Anne Candy Company, a Delaware corporation f/k/a Gray & Company ("**Queen Anne**"), were parties to a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), pursuant to which Queen Anne granted a security interest to the Releasing Party in, and a collateral assignment to the Releasing Party of, among other things, the trademark registrations and trademark applications (and intellectual property relating to same) of Queen Anne, including, without limitation, the trademark registrations and trademark applications (and intellectual property relating to same) set forth on Schedule 1 hereto;

WHEREAS, in connection with entering into the Security Agreement, a Notice of Recordation of Assignment Document was recorded in the United States Patent and Trademark Office on December 9, 1993 at Reel 1072, Frame 0329; and

WHEREAS, Queen Anne has requested that the Releasing Party release its security interest in the trademark registrations and trademark applications of Queen Anne and reassign the same to Queen Anne.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Releasing Party hereby releases its security interests in all of Queen Anne's right, title and interest in and to all of the following (the "**Trademark Collateral**"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claims by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Releasing Party hereby reassigns, grants and conveys to Queen Anne, without any representation, recourse or undertaking by Releasing Party, all of Releasing Party's right, title and interest in and to the Trademark Collateral.
