WHEREAS, reference is made to (i) that certain Credit Agreement dated as of January 26, 2007 (as amended, supplemented or otherwise modified, the "Credit Agreement"), by and among ARAMARK CORPORATION, a Delaware corporation ("ARAMARK" or the "U.S. Borrower"), as successor to RMK ACQUISITION CORPORATION, ARAMARK, ARAMARK CANADA LTD., a company organized under the laws of Canada (the "Canadian Borrower"), ARAMARK INVESTMENTS LIMITED, a limited company incorporated under the laws of England and Wales (the "U.K. Borrower"), ARAMARK IRELAND HOLDINGS LIMITED, a company incorporated under the laws of Ireland (the "Irish Borrower"), ARAMARK HOLDINGS GMBH & CO. KG, a company organized under the laws of Germany (the "German-1 Borrower"), ARAMARK GMBH, a company organized under the laws of Germany (the "German-2 Borrower" and, together with the U.S. Borrower, the Canadian Borrower, the U.K. Borrower, the Irish Borrower and the German-1 Borrower, the "Borrowers"), ARAMARK INTERMEDIATE HOLDCO CORPORATION, a Delaware corporation ("Holdings"), each Subsidiary of ARAMARK that, from time to time, becomes a party hereto, the Lenders (as defined in Article I), JPMORGAN CHASE BANK, N.A., as LC Facility Issuing Bank (in such capacity, the "LC Facility Issuing Bank"), the Issuing Banks named therein, CITIBANK, N.A., as administrative agent and collateral agent for the Lenders thereunder (in such capacities, the "Agent", and the other parties thereto from time to time (ii) that certain Security Agreement dated as of January 26, 2007 by and among each of the Borrower, the Agent and other parties party thereto (as amended, supplemented or otherwise modified, the "Security Agreement'), and (iii) that certain Pledge Agreement dated as of Janary 26, 2007 by and among each of the Borrower, the Agent and other parties party thereto (as amended, supplemented or otherwise modified, the "Pledge Agreement" and together with the Security Agreement, the "Security Agreements"); capitalized terms not defined herein shall have the meanings assigned to them in the Collateral Agreement;

WHEREAS, reference is also made to the Trademark Security Agreement dated January 26, 2007, by and among ARAMARK CLEANROOM SERVICES, INC., the Borrower, ARAMARK REFRESHMENT SERVICES, INC., ARAMARK SERVICES, INC., ARAMARK SPORTS AND ENTERTAINMENT SERVICES, INC., ARAMARK UNIFORM AND CAREER APPAREL GROUP, INC., ARAMARK UNIFORM AND CAREER APPAREL, INC., GALLS, INC., RESTAURA, INC. and SEAMLESSWEB PROFESSIONAL SOLUTIONS, INC. (individually, a "Pledgor" and collectively, the "Pledgors"), and the Agent (the "Trademark Security Agreement"); and

WHEREAS, pursuant to the Trademark Security Agreement recorded with the U.S. Patent and Trademark Office at Reel 003476, Frame 0625 on February 7, 2007, each

Pledgor granted the Agent a lien on and security interest in and to all of its right, title and interest in, to and under certain of its intellectual property Collateral, including the Marks listed on Schedule I hereto and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Amendment Agreement, dated as of March 26, 2010 (the "Amendment"), among the Borrowers and the Required Lenders (as defined in the Credit Agreement), Assignor and Assignee, the Credit Agreement has been amended to reflect, among other things, the appointment of Assignee as successor administrative agent and collateral agent; and

WHEREAS, in furtherance of Assignee's replacement of Assignor as the Agent under the Credit Agreement, Assignee is desirous of acquiring and Assignor is desirous of assigning all of its right, title and interest in, to and under the Trademark Security Agreement, including without limitation the Assigned Interest (as defined below), and all documents relating thereto.

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto agree as follows:

Assignor hereby irrevocably, absolutely and unconditionally assigns to Assignee without recourse and without any representation or warranty of any kind, nature or description, and Assignee hereby assumes from Assignor, the interest in and to Assignor's rights and obligations under the Trademark Security Agreement (the "Assigned Interest") and all Marks listed on Schedule I hereto, as of the Effective Date (as defined below).

The effective date of this Assignment and Assumption shall be the date of execution by all parties (the "<u>Effective Date</u>"). Following the execution of this Assignment and Assumption, it will be delivered to Cahill Gordon & Reindel LLP for recording on behalf of the parties hereto pursuant to the Security Agreements and the Trademark Security Agreement with the United States Patent and Trademark Office.

From and after the Effective Date (a) Assignee shall be a party to the Credit Agreement, the Security Agreements, and the Trademark Security Agreement and, to the extent provided in this Assignment and Assumption, have the rights and obligations of the Agent thereunder and shall be bound by the provisions thereof and (b) Assignor shall, to the extent provided in this Assignment and Assumption, relinquish its rights and be released from its obligations under the Credit Agreement, the Security Agreements and the Trademark Security Agreement.

This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.

This Assignment and Assumption may be executed by one or more of the parties to this Assignment and Assumption in any number of separate counterparts (including by telecopy or Adobe PDF), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
