INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT is dated as of June 29, 2010 (this "*IP Security Release*") and executed and delivered by Bank of America, N.A., as administrative agent (the "*Administrative Agent*") for the Secured Parties, in favor of THL Food Products Co., THL Food Products Holdings Co., Michael Foods of Delaware, Inc., Casa Trucking, Inc., Crystal Farms Refrigerated Distribution Company, KMS Dairy, Inc., Minnesota Products, Inc., Northern Star Co., Papetti's Hygrade Egg Products, Inc., M.G. Waldbaum Company, Farm Fresh Foods, Inc., Papetti Electroheating Corporation, WFC, Inc. and Wisco Farm Cooperative (each, a "*Grantor*," and collectively the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the IP Security Agreement and Credit Agreement (as defined below).

WHEREAS, THL Food Products Co., a Delaware corporation, has entered into a Credit Agreement dated as of November 20, 2003 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with THL Food Products Holding Co., a Delaware corporation, Bank of America, N.A., as the L/C Issuer, the Swing Line Lender and the Administrative Agent, the other Agents named therein and the Lenders party thereto;

WHEREAS, pursuant to the Credit Agreement, the Grantor and certain other Persons have executed and delivered that certain Security Agreement dated November 20, 2003 made by the Grantor and such other Persons to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*") and that certain Intellectual Property Security Agreement dated November 20, 2003 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on January 20, 2004, on reel 14892 frame 753 and with the Trademark Division of the United States Patent and Trademark Office on November 20, 2003, on reel 2897 frame 532;

WHEREAS, the Administrative Agent has agreed to release the security interest granted pursuant to the IP Security Agreement in and to the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Administrative Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, all of the Administrative Agent's right, title and interest in and to the Collateral, including its right, title and interest in and to the Patents identified in Schedule A and the Trademarks identified in Schedule B attached hereto.



SECTION 2. Recordation. The Administrative Agent authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Release.

SECTION 3. Execution in Counterparts. This IP Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which together shall constitute one and the same instrument.

SECTION 2. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent has caused this IP Security Release to be duly executed and delivered by a duly authorized officer as of the date first above written.
