PARTIAL RELEASE AND ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to that certain Trademark Collateral Agreement (Short-Form) dated as of February 8, 2010, among PAPERWEIGHT DEVELOPMENT CORP., a Wisconsin corporation ("**Paperweight**"), APPLETON PAPERS INC., a Delaware corporation ("**Appleton**"), AMERICAN PLASTICS COMPANY, INC., a Wisconsin corporation ("**American Plastics**"), and NEW ENGLAND EXTRUSION INC., a Wisconsin corporation ("**New England Extrusion**", together with Paperweight, Appleton and American Plastics, collectively, the "**Grantor**"), in favor of FIFTH THIRD BANK, an Ohio banking corporation, as administrative agent (the "**Administrative Agent**"), which was recorded with the United States Patent and Trademark Office with regard to certain trademarks of Grantor on February 8, 2010, at Reel 004145, Frame 0219, Grantor granted to Administrative Agent for the benefit of certain lenders (the "**Lenders**") a security interest in and lien on all of Grantor's interest in and to the collateral described therein, including without limitation, those trademarks and trademark applications described on the attached Schedule A, made a part hereof (collectively, the "**Specified Trademark Collateral**");

WHEREAS, Administrative Agent, on behalf of itself and the Lenders, desires to release its security interest in, and lien and any other encumbrance on, the Specified Trademark Collateral listed on Schedule A, made a part hereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of itself and the Lenders does hereby release its security interest in and lien on the Specified Trademark Collateral listed on Schedule A and reassigns to Grantor, without representation or warranty, express or implied, and without recourse, all right, title and interest of Administrative Agent and the Lenders, in and to Grantor's interest in such Specified Trademark Collateral listed on such Schedule.
