**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Agreement") is dated as of July 29, 2010, from KEYBANK NATIONAL ASSOCIATION, as the collateral agent (the "Collateral Agent") to CEDAR FAIR, L.P., a Delaware limited liability partnership (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of June 30, 2006, as amended and restated on August 30, 2006 and as further amended and restated on February 15, 2007 (the "Amended and Restated Credit Agreement") among Cedar Fair, L.P. and Canada's Wonderland Company (as successor to 3147010 Nova Scotia Company), certain of the lenders party thereto, and Keybank National Association, as administrative agent and collateral agent, among others, the lenders agreed to extend credit on a revolving basis and make term loans to Cedar Fair, L.P. and Canada's Wonderland Company (as successor to 3147010 Nova Scotia Company) upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection with the Amended and Restated Credit Agreement, Cedar Fair, L.P. and certain of its subsidiaries executed and delivered a Guarantee and Collateral Agreement, dated as of June 30, 2006, in favor of the Collateral Agent (as amended, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement");

WHEREAS, in connection with the Guarantee and Collateral Agreement, the Grantor and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of June 30, 2006 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Grantor thereby assigned and transferred to the Collateral Agent, and thereby granted to the Collateral Agent, for the ratable benefit of the secured parties, a security interest in all of the Trademarks (including, without limitation, those items listed on Schedule A hereto), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Grantor's obligations (the "Security Interest");

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on August 10, 2006 at Reel Frames 3366/0857, 3366/0943 and 3366/0890.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks and Trademark Licenses pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Collateral Agent hereby states as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided (or incorporated by reference) in the Amended and Restated Credit Agreement and the Guarantee and Collateral Agreement.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges its Security Interest in the Trademarks and Trademark Licenses, and any right, title or interest of the Collateral Agent in such Trademarks and Trademark Licenses shall hereby cease and become void.

3. Authorization to File. The Collateral Agent hereby authorizes the Grantor or its authorized representative to (i) file this Agreement with the United States Patent and Trademark Office and (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of the Security Interest.

4. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
