WORLDWIDE OMNIBUS ASSIGNMENT OF TRADEMARKS AND DOMAIN NAMES

This assignment agreement (the "**Assignment**") is entered into this 30th day of July, 2010 (the "**Effective Date**") by and between Motorola, Inc., which will change its name on or about January 1, 2011, and be known as Motorola Solutions, Inc., a Delaware corporation with a principal address of 1303 E. Algonquin Road, Schaumburg, IL 60196 ("**MINC**" or "**Assignor**") and Motorola Trademark Holdings, LLC, a Delaware limited liability company, with a principal address of 600 North US Highway 45, Libertyville, IL 60048 ("**Motorola Holdco**" or "**Assignee**") (Assignor and Assignee each a "**Party**" and together the "**Parties**").

WHEREAS, MINC has determined that it would be appropriate, desirable and in the best interests of MINC and MINC's stockholders to separate the Mobile Devices and Home businesses (collectively, the "**Transferred Businesses**") from MINC;

WHEREAS, in order to effectuate the foregoing, MINC, Motorola SpinCo Holdings Corporation, a Delaware corporation and wholly-owned subsidiary of MINC ("**Spinco**"), and Motorola Mobility, Inc., a Delaware corporation and wholly-owned subsidiary of MINC ("**Mobility**") are entering into a Master Separation and Distribution Agreement ("**MSDA Agreement**"), which provides, among other things, subject to the terms and conditions thereof for the contribution or transfer of certain assets and liabilities of the Transferred Businesses to Spinco, Mobility and certain of their Subsidiaries and the Distribution, each of the foregoing terms as more specifically defined in the MSDA Agreement (collectively, the "**Separation Transactions**"), and the execution and delivery of certain other agreements in order to facilitate and provide for the foregoing;

WHEREAS, in connection with the Separation Transactions, MINC is contributing all of its rights, title and interests in, to and under the "Motorola," "Moto" and other trademarks, service marks, trade names, logos, slogans, designs, trade dress, domain names and other proprietary designations, including but not limited to the applications and registrations therefor set forth on Schedule A hereto and the domain name registrations set forth on Schedule C hereto, and all other applications and registrations therefor, along with all related common law marks and all appurtenant goodwill (collectively, the "**Motorola Marks**") to Assignee, except that MINC will have a right to continue to use certain Motorola Marks pursuant to the terms, conditions and limitations of a separate written license agreement between MINC and Assignee ("**Exclusive License Agreement**").

WHEREAS, in connection with the Separation Transactions, MINC is also contributing all of its rights, title and interests in, to and under certain other trademarks, service marks, trade names, logos, slogans, designs, trade dress, domain names and other proprietary designations, including but not limited to the applications and registrations therefor set forth on Schedule B hereto and the domain name registrations set forth on Schedule D hereto, and all other applications and registrations therefor, along with all related common law marks and all appurtenant goodwill (collectively, the "**Mobility Marks**") to Assignee (Motorola Marks and Mobility Marks together the "**Assigned Motorola Marks**").

WHEREAS, Assignor, is the owner of all right, title and interests in, to and under the Assigned Motorola Marks; and

WHEREAS, Assignee, is desirous of acquiring the Assigned Motorola Marks and the goodwill associated therewith;

NOW THEREFORE, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

Section 1. Assignment.

Assignor hereby assigns, transfers, conveys and sets over to Assignee all right, title and interest, in, to and under the Assigned Motorola Marks owned by Assignor, including any common law rights, together with the goodwill of the business symbolized by said Assigned Motorola Marks and any common law marks, and trademark registrations, applications and renewals thereof, any renewal rights therein, domain name registrations, any renewal rights therein, and subject to the Exclusive License Agreement pertaining to certain Motorola Marks, all income, royalties, damages and payments now or hereafter due or payable in respect to the Assigned Motorola Marks, and all causes of action, either in law or in equity, and the exclusive right to enforce, sue, counterclaim and recover for past, present and future infringement of the Assigned Motorola Marks and the rights thereto in the United States and throughout the world in the sole name of Assignee, its successors and assigns; the aforesaid transferred rights, title and interests to be held and enjoyed by Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.

Section 2. Covenants by Assignor.

Following the execution of this Assignment and at Assignee's reasonable request, Assignor shall provide Assignee with whatever reasonable assistance is required in the preparation of all other assignment documents necessary or desirable to confirm, effect or perfect the assignment and transfer to Assignee of all of Assignor's right, title, and interest in all of Assigned Motorola Marks as set forth on Schedule A, Schedule B, Schedule C and Schedule D and all related goodwill. At the request of Assignee, Assignor shall timely execute and deliver, and shall designate a responsible person, as applicable, who shall in the future, timely execute and deliver, following receipt of the payment for the documented costs thereof, all such assignment documents to Assignee. Until such time as all of the assignments of Assignor's Assigned Motorola Marks in all countries set forth on Schedule A, Schedule B, Schedule C and Schedule D are duly recorded with the responsible government offices or registrars (the "Interim Period"), Assignor acknowledges and confirms that Assignee shall, in any event, be deemed hereunder and in accordance with the terms and conditions of this Assignment, to be the owner of Assignor's Assigned Motorola Marks set forth on Schedule A, Schedule B, Schedule C and Schedule D.

If it shall be necessary to record this Assignment, or other confirmatory documentation during the Interim Period, or in the event that any of Assignor's Assigned Motorola Marks shall

become due for any renewals, maintenance filings or other recordations during the Interim Period, Assignor shall likewise cooperate with Assignee's reasonable requests and hereby consents and grants to Assignee the right to take whatever action is necessary, in Assignee's judgment, and at Assignee's sole cost and expense, to maintain and enforce all registrations and other filings throughout the world. All recordations and filings of Assignments of Assignor's Assigned Motorola Marks and other materials confirming ownership by Assignee shall be made at Assignee's request or direction.

Section 3. Inadvertent Omission of Motorola Marks or Mobility Marks from the Assigned Motorola Marks set forth on Schedule A, Schedule B, Schedule C or Schedule D.

In the event that either Party becomes aware that (i) a trademark or domain name used by one of the Transferred Businesses prior to the Effective Date; (ii) a trademark or domain name which contains a portion of a Motorola Mark or a Mobility Mark set forth on Schedule A or Schedule B; or (iii) a trademark or domain name owned by a subsidiary or affiliate of Assignor that was intended to be assigned to Assignee, was not included in the Assigned Motorola Marks set forth on Schedule A, Schedule B, Schedule C or Schedule D, and thus should have originally been included on Schedule A, Schedule B, Schedule C or Schedule D, the Parties agree to amend this Assignment to add the inadvertently omitted trademark(s) or domain names(s) to the Assigned Motorola Marks set forth on Schedule A, Schedule B, Schedule C or Schedule D, as appropriate.



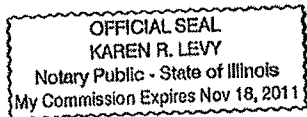


