#### TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "<u>Assignment</u>") is dated as of July 30, 2010 (the "<u>Closing Date</u>"), by and among:

- (A) BEAVER-VISITEC INTERNATIONAL (US), INC., a company incorporated in Delaware, having its principle place of business at 411 Waverly Oaks Rd, Waltham, Massachusetts, 02452-8422 ("BVI");
- (B) SIZZLE SALES CO. (UK) LIMITED, a private company limited by shares incorporated in the United Kingdom, having its principle place of business at Waterloo Industrial Estate Waterloo Road, Bidford-on-Avon, Warwickshire, B504JH, United Kingdom ("Sizzle," and together with BVI US, each an "Assignee" and collectively, the "Assignees"); and
- (C) BECTON, DICKINSON AND COMPANY, a company incorporated in New Jersey, having its principle place of business at 1 Becton Drive, Franklin Lakes, New Jersey ("Seller or Assignor").

Capitalized terms which are used but not defined herein shall have the meanings ascribed to such terms in the Asset Purchase Agreement, dated as of May 28, 2010, by and among Beaver-Visitec International Holdings, Inc. (f/k/a Sizzle Holdings Corp.), a company incorporated in Delaware, the Assignor, and certain other affiliates of the foregoing (the "Asset Purchase Agreement").

#### **RECITALS**

**WHEREAS**, the Assignor has adopted and used and are using in commerce the marks set forth in the attached Schedule A (collectively, the "Marks"); and

**WHEREAS**, pursuant to the Asset Purchase Agreement, Assignees wish to acquire from the Assignor, and the Assignor wishes to transfer to Assignees, said Marks and the goodwill associated with such Marks as set forth on <u>Schedule A</u>;

WHEREAS, in conjunction with this Marks Assignment, each Assignee is acquiring the portion of Assignor's business to which the Marks being assigned to such Assignee pertain; and

WHEREAS, all of the terms and conditions precedent provided in the Asset Purchase Agreement have been met and performed by the respective parties thereto, and the Assignor and Assignees now desire to carry out the intent and purpose of the Asset Purchase Agreement by the Assignor's execution and delivery to the Assignees of this instrument evidencing the assignment by the Assignor and the assumption by Assignees of all the Marks in accordance with Schedule A.

**NOW, THEREFORE**, in consideration of the foregoing recitals and the mutual representations, warranties, covenants and promises contained herein, the adequacy and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Effective as of the Closing Date, the Assignor hereby assigns to the applicable Assignee all rights, title and interests in and to the Marks, the goodwill of the business symbolized by the Marks, all registrations and applications for registration thereof, if any, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement of said Marks, as set forth on Schedule A.

Section 2. Effective upon the Closing Date, the Assignor authorizes and requests the United States Patent and Trademark Office, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications for registration, to record the applicable Assignee as the assignee and owner of any and all of the Assignor's rights in the Marks being assigned to such Assignee in accordance with Schedule A.

Section 3. After the Closing Date and at any Assignee's request, the Assignor will, at such Assignee's sole expense, provide further cooperation reasonably necessary (such as executing and delivering additional assignments, affidavits, and other documents and providing information and materials) to obtain, perfect, and defend the Marks in the United States or any foreign country.

<u>Section 4</u>. Each of the Assignor and Assignees hereby acknowledges and agrees that none of the representations, warranties, covenants, rights or remedies of any party under the Asset Purchase Agreement shall be deemed to be enlarged, modified or altered in any way by the execution and acceptance of this instrument.

Section 5. The rights and obligations of the parties shall be governed by, and this Assignment shall be interpreted, construed and enforced in accordance with, the laws of the State of New York, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction.

<u>Section 6</u>. This Assignment may be signed in any number of counterparts, including facsimile copies thereof or electronic scan copies thereof delivered by electronic mail, each of which shall be deemed an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.
