Reference is made to (i) the Second Amended and Restated Credit Agreement dated as of April 5, 2007, as amended by the Additional Term Facility Amendment dated as of July 1, 2008 (as amended, supplemented or otherwise modified, the "Credit Agreement), among Vertafore, Inc., a Delaware corporation (the "Company"), VF Holding Corp., a Delaware corporation ("Holdings"), the Lenders party thereto, JPMorgan Chase Bank, N.A., as administrative agent and as collateral agent (in such capacities, the "Administrative Agent" and the "Collateral Agent" respectively), and the other agents party thereto, (ii) the Amended and Restated Pledge and Security Agreement, dated as of December 22, 2004 (as amended and restated as of April 5, 2007 and amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Company, Holdings, the Subsidiaries of the Company party thereto and the Collateral Agent, (iii) the Joinder Agreement dated as of June 30, 2008, between Sircon Corporation and the Administrative Agent (the "Joinder Agreement"), (iv) the Amended and Restated Trademark Security Agreement dated as of April 5, 2007 (as supplemented or otherwise modified, the "First Trademark Security Agreement") among the Company, SilverPlume Reference Systems, Inc.
