## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks is granted and conveyed as of August 20, 2010, by BANK OF AMERICA, N.A., as administrative agent for the Lenders (as defined below) under the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), in favor of ICON IP, Inc., a Delaware corporation ("ICON IP").

WHEREAS, reference is made to the Amended and Restated Revolving Credit and Term Loan Agreement, dated as of September 6, 2007 (as amended, amended and restated, or otherwise modified to the date hereof, the "Credit Agreement"), by and among ICON Health & Fitness, Inc., a Delaware corporation (the "Borrower"), ICON IP and the other Credit Parties signatory thereto, the lenders party thereto (collectively, the "Lenders") and Bank of America, N.A., as Administrative Agent.


WHEREAS, the records of the United States Patent and Trademark Office ("PTO") reflect that the Administrative Agent and ICON IP entered into a Trademark Collateral Security and Pledge Agreement dated as of October 31, 2005 (the "Agreement"), under which ICON IP granted to the Administrative Agent a security interest in ICON IP's interest in the trademark registrations and trademark applications listed on the attached Schedule A (collectively, the "Marks").

WHEREAS, the Administrative Agent seeks to make a record of the Administrative Agent's release to ICON IP of the security interest granted by ICON IP in the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Administrative Agent hereby (1) releases, discharges, and relinquishes, as of August 20, 2010, the security interest granted by ICON IP in the Marks.
