TERMINATION OF TRADEMARKS SECURITY AGREEMENT


WHEREAS, NewRiver Investor Communication, Inc., a Massachusetts corporation, located at 200 Brickstone Square, 5th Floor, Andover, Massachusetts 01810 (the "Company") and Fleet National Bank n/k/a Bank of America, N.A., located at 100 Federal Street, Boston, Massachusetts 02110 (the "Bank"), entered into a certain Security Agreement (Trademarks) (the "Security Agreement"), dated as of August 28, 2000, which was recorded in the United States Patent and Trademark Office on September 7, 2000 at Reel 2143 and Frame 0024, that by its terms granted the Bank a security interest in certain intellectual property listed in Schedule A (the "Trademarks") to the Security Agreement and all trademark applications and trademark registrations acquired or arising after the date of the Agreement;

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Trademarks was granted.

NOW THEREFORE the Bank hereby reassigns to the Company the interest in the Trademarks listed on Exhibit A attached hereto in which Bank was granted a security interest under the Security Agreement. The Bank also hereby releases its security interest in the Trademarks listed in Exhibit A attached hereto. The Bank further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Company, to effectuate this termination.
