RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of August 13, 2010 (the "Effective Date") by Citicorp North America, Inc., as successor in interest and assignee of Calyon New York Branch) (in such capacity, the "Agent"), for the benefit of EnergySolutions, LLC, a Utah limited liability company (the "Parent"), Manufacturing Sciences Corporation, BNG America LLC, Chem-Nuclear Systems, LLC, Duratek, Inc., Duratek Services, Inc., and Infotek, Inc.(each a "Grantor" and, collectively, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Amended and Restated Trademark Security Agreement, dated as of June 7, 2006, and that certain Supplemental Trademark Security Agreement, dated as of September 23, 2009, between the Grantors and the Agent (collectively, the "Collateral Agreements"), the Grantors granted to the Agent a continuing security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired: (a) all of its trademarks and trademark licenses to which it is a party including, without limitation, those set forth on Schedule 1 attached hereto; (b) all renewals or extensions of the foregoing; (c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark license; and (d) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future: (i) infringement or dilution of any trademark or trademark licensed under any trademark license, and (ii) injury to the goodwill associated with any trademark or any trademark licensed under any trademark license (collectively, the "Trademarks");

WHEREAS, the Agent has agreed to release its interest in and to the Trademarks and discharge the Collateral Agreements.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Collateral Agreements, and hereby terminates, releases, relinquishes, discharges, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, including, without limitation, the trademarks and trademark licenses set forth on Schedule 1 attached hereto.

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Agent hereby agrees to, at the sole expense of the Grantor, duly execute, acknowledge, procure and deliver any further documents necessary under the rules and other applicable laws of the various jurisdictions, and to do such other acts as may be reasonably necessary upon request of the Grantor (or its assignees or designees) to effectuate the release of the security interest contemplated hereby and to confirm this Release and Grantor's (or its assignee's) right, title and interest in and to the Trademarks.

This Release shall be governed by and construed and enforced in accordance with the laws of the State of New York without giving effect to New York choice of law doctrine.
