**TERMINATION OF SECURITY INTEREST IN  
PATENTS AND TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (the "Termination"), dated as of August 30, 2010, is executed by Cisco Systems Capital Corporation, a Nevada corporation as collateral agent for the benefit of the individuals and entities set forth on Exhibit A to the Security Agreement (as defined below) ("CSCC"), in favor of airBand Communications, Inc, a Delaware corporation (together with its successors and assigns, "Grantor"). (Capitalized terms used herein have the meaning assigned in the Security Agreement.)

Recitals

A. In connection with that certain Security Agreement, dated as of December 18, 2000 (as amended from time to time, the "Security Agreement"), executed by Grantor in favor of CSCC, Grantor and CSCC entered into an Patent and Trademark Security Agreement, dated as of December 18, 2000 (the "Agreement"), wherein Grantor granted to CSCC a security interest in the Collateral. The Collateral included, without limitation, all Intellectual Property of the Grantor.

B. The Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 2, 2001, at Reel/Frame 2217/0019 to evidence the security interest granted under the Security Agreement.

C. Grantor has satisfied in full the Obligations (as defined in the Security Agreement) under and secured by the Security Agreement and CSCC has agreed to terminate and release its security interest in the Patents and Trademarks (as defined below) as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CSCC expressly terminates and releases its security interest in, to and under the following Patents and Trademarks (collectively, the "Collateral"):

(i) all patents and patent applications, domestic or foreign, of Grantor, all licenses relating to any of the foregoing and all income and royalties with respect to any licenses (including such patents and patent applications as described in Schedule A), all rights to sue for past, present or future infringement thereof, all rights arising therefrom and pertaining thereto and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof (the "Patents");

(ii) all state (including common law), federal and foreign trademarks, service marks and trade names of Grantor, and applications for registration of such trademarks, service marks and trade names, all licenses relating to any of the foregoing and all income and royalties with respect to any licenses (including such marks, names and applications as described in Schedule B), whether registered or unregistered and wherever registered, all rights to sue for past, present or future infringement or unconsented use thereof, all rights arising therefrom and pertaining thereto and all reissues, extensions and renewals thereof (the "Trademarks");

(iii) the entire goodwill of or associated with the businesses now or hereafter conducted by Grantor connected with and symbolized by any of the aforementioned properties and assets;

(iv) all general intangibles and all intangible intellectual or other similar property of Grantor of any kind or nature, associated with or arising out of any of the aforementioned properties and assets and not otherwise described above; and


(v) all proceeds of any and all of the foregoing Collateral (including license royalties, rights to payment, accounts receivable and proceeds of infringement suits) and, to the extent not otherwise included, all payments under insurance (whether or not CSCC is the loss payee thereof) or any indemnity, warranty or guaranty payable by reason of loss or damage to or otherwise with respect to the foregoing Collateral.

CSCC authorizes and requests that the Commissioner for Patents and Trademarks and any other governmental officer record this Termination.
