WHEREAS, ASSIGNOR is the owner of a federal trademark registration for the DGK trademark;





- (3) any and all other registrations for the Trademarks owned anywhere in the world by ASSIGNOR;

together with the goodwill symbolized by the Trademarks, concurrent with the transfer of certain tangible assets as indicia of said goodwill. This Agreement may be executed in duplicate and in counterparts, each of which shall be an original and all of which shall constitute one and the same agreement.
