**TERMINATION OF
TRADEMARK SECURITY AGREEMENT**

This TERMINATION OF TRADEMARK SECURITY AGREEMENT dated as of June 30, 2010, is by **REGIONS BANK**, in its capacity as Collateral Agent for Lenders in favor of **VICTOR EQUIPMENT COMPANY**, a Delaware corporation ("Grantor").

W I T N E S S E T H:

WHEREAS, pursuant to that certain 2009 Amended and Restated Second Lien Credit Agreement dated as of August 14, 2009 by and among Grantor, the other Persons named therein as Borrowers, Collateral Agent and the Persons signatory thereto from time to time as Lenders and Guarantors (including all exhibits or schedules thereto, and as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement"), Lenders have made the Loans for the benefit of Grantor and the other Borrowers party thereto;

WHEREAS, Grantor and Collateral Agent for Lenders entered into a certain Trademark Security Agreement dated as of August 14, 2009, whereby Grantor granted to Collateral Agent, on behalf of itself and Lenders, a continuing security interest in and mortgage on all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its Trademarks and Trademark Licenses together with all prints and labels on which said Trademarks have appeared or appear, designs and general intangibles of like nature, now existing or hereinafter adopted or acquired and the applications, registrations and recordings in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any states thereof, or any other country or subdivision thereof, to which it is a party including those referred to on Schedule I hereto;

(b) all renewals of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in Section 1.01 of the Credit Agreement.

2. TERMINATION OF GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Collateral Agent acknowledges that the Loans have been paid in full and agrees that the continuing security interest in and mortgage on all of Grantor's right, title and interest in, to and under the Trademark Collateral is hereby terminated and released.

3. COUNTERPARTS. This Termination of Trademark Security Agreement may be authenticated in any number of separate counterparts, each of which shall collectively and separately constitute one agreement. This Termination of Trademark Security Agreement may be authenticated by manual signature, facsimile or, if approved in writing by Grantor, electronic means, all of which shall be equally valid.
