WHEREAS, pursuant to the Loan and Security Agreement, dated as of October 3, 2008, as amended on April 29, 2010 ("Security Agreement"), among Associated Materials, LLC (f/k/a Associated Materials, Inc.), Gentek Building Products, Inc. (collectively, "Debtor"), Gentek Building Products Limited, Associated Material Holdings, LLC, Gentek Holdings, LLC, and Associated Materials Finance, Inc. (f/k/a Alside, Inc.), and the Secured Party, by which a security interest was granted by the Debtor to the Secured Party in the Trademark Collateral (as hereinafter defined); and
