RELEASE OF SECURITY INTEREST IN IP

This RELEASE OF SECURITY INTEREST IN IP, dated as of October 19th, 2010 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association as trustee, located at Sixth Street and Marquette Avenue MAC N9311-161, Minneapolis, Minnesota 55479, attention Corporate Trust Services/Asset Backed Administration (the "Assignor"), in favor of IHOP FRANCHISING, LLC a Delaware limited liability company, located at c/o of International House of Pancakes, Inc., 450 North Brand Boulevard, Glendale, California 91203-2306 (the "Assignee") and IHOP IP, LLC, a Delaware limited liability company, located at c/o of International House of Pancakes, Inc., 450 North Brand Boulevard, Glendale, California 91203-2306 (the "Co-Assignee" and together with the Assignee, the "Co-Assignees").

All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement (as defined below).

WITNESSETH

WHEREAS, the Co-Assignees and the Assignor are parties to that certain Base Indenture, dated as of March 16, 2007, (the "Base Indenture," and as amended, modified or supplemented and each Series Supplement executed pursuant to the Base Indenture, as amended, modified or supplemented, collectively, the "Indenture") whereby the Co-Assignees issued Notes upon the terms and subject to the conditions of the Indenture;

WHEREAS, pursuant to the Indenture, the Co-Assignees executed and delivered to Assignor that certain IP Security Agreement, dated March 16, 2007 (the "IP Security Agreement"), to secure the Notes and the prompt and complete payment and observance and performance of the Secured Obligations;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on March 26, 2007 at Reel/Frame No. 3508/0490;

WHEREAS, the IP Security Agreement was recorded with the Mexican Patent and Trademark Office as from March 26, 2007, under acknowledgements dated March 23, 2010;

WHEREAS the IP Security Agreement was recorded with the Canadian Intellectual Property Office on April 11, 2007 at File No. 292999;

WHEREAS, pursuant to the IP Security Agreement, each of the Co-Assignees Granted to the Assignor, for its own benefit and security and for the benefit and security of the other Secured Parties, all of the Assignee's and the Co-Assignee's assets, respectively, including each of the Co-Assignees' right, title and interest in, to and under, in each case, whether then owned or existing, of thereafter acquired or arising, in all of the following:

(a) the IP Assets, including, without limitation, the Trademarks, Patents and Copyrights which are the subject of the registrations and applications referred to on Schedule A thereto (as amended or supplemented) and the

right to bring an action at law or in equity for any infringement, dilution or violation thereof occurring prior to, on or after the Closing Date, and to collect all damages, settlement and proceeds relating thereto;

- (b) the IP License Agreement;
- (c) with respect to the Grant by the Assignee, the Assignee's rights in the Licensed IP granted by the Co-Assignee to the Assignee to secure the Co-Assignee's obligations under the IP License Agreement; and
- (d) all payments, proceeds and accrued and future rights to payment with respect to the foregoing (the assets, rights and interests described in clauses (a) and (b) of the Granting Clauses, subject to the proviso below, collectively referred as the "IP Collateral"),

provided that the IP Collateral did not include, with respect to the Assignee and the Co-Assignee, any rights to use third party Intellectual Property to the extent that such rights were not assignable; provided, further, that any applications for trademarks and service marks filed in the United States Patent and Trademark Office on the basis of the applicant's intent to use such mark pursuant to 15 U.S.C. Section 1051, were not included in the IP Collateral unless and until evidence of use of such mark in interstate commerce was submitted to the United States Patent and Trademark Office pursuant to 15 U.S.C. Section 1060(a), whereupon, such application was deemed to be automatically included in the IP Collateral;

WHEREAS, such Grants were made in trust to secure the Notes equally and ratably without prejudice, priority or distinction between any Note and any other Note by reason of difference in time of issuance or otherwise, except as expressly provided in the Indenture, and to secure the prompt and complete payment and observance and performance of the Secured Obligations;

WHEREAS, the IP Security Agreement terminates upon the termination of the Indenture, as provided in Section 4 of the IP Security Agreement;

WHEREAS, the Indenture is being satisfied and discharged, and the interests granted to Assignor thereunder are being released, on the date hereof; and

WHEREAS, in connection with the termination of the Indenture, the Assignor and the Co-Assignees desire that the Assignor terminate and release its Grants in, to and under the IP Collateral, including, without limitation, the IP Assets set forth in <u>Schedule I</u> hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

The Assignor hereby terminates, releases and discharges fully its Grants in, to and under all of the IP Collateral, including but not limited to the IP Assets on Schedule I hereto, and

reassigns and transfers any right, title and interest that the Assignor may have in the IP Collateral to the Co-Assignees.

The Assignor hereby authorizes the Co-Assignees or the Co-Assignees' authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Grant of the Assignor in the IP Collateral, (iii) otherwise record or file this Release in the applicable governmental office or agency, (iv) record this Release with the Mexican Patent and Trademark Office, and (v) record this Release with the Canadian Intellectual Property Office. The Assignor further agrees to execute and deliver to the Co-Assignees any and all further documents and instruments, and do any and all further acts which the Co-Assignees (or its agents or designees) reasonably request (at the Co-Assignees' sole cost and expense) in order to confirm this Release and the Co-Assignees' right, title, and interest in or to the IP Collateral.

The Assignor acknowledges and agrees that the Co-Assignees and their respective successors and assigns may rely upon this Release. Assignor represents and warrants that it has not transferred or assigned all or any part of its Grants in, to and under all of the IP Collateral, and that it has all necessary authority to execute the releases and discharges and all other rights set forth herein.

THIS RELEASE SHALL BE GOVERNED BY THE INTERNAL LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CHOICE OF LAW RULES (OTHER THAN SECTION 5-1401 OF THE NEW YORK GENERAL OBLIGATIONS LAW).
