TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is effective and entered into on this 12th day of August, 2010, by and between Texas Rangers Baseball Partners, a Texas general partnership ("TRBP" or "Assignor") and Rangers Baseball LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor and Rangers Baseball Express LLC, a Delaware limited liability company and sole member of Assignee, are parties to a certain Asset Purchase Agreement dated as of May 23, 2010 (as amended, restated, supplemented or otherwise modified from time to time pursuant to its terms) ("Purchase Agreement"), pursuant to the terms of which Assignor agreed to assign certain of Assignor's intellectual property to Assignee ("Purchased Intellectual Property");

WHEREAS, the Purchased Intellectual Property includes the trademarks and service marks owned by Assignor (the "Marks") and trademark applications and registrations covering rights in said Marks as listed on *Schedule A* attached hereto (the "Registrations"); and

WHEREAS, Assignor and Assignee are desirous of making this Agreement a matter of record in appropriate trademark offices and/or registrars.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor does hereby sell, assign and transfer to Assignee, absolutely and forever, and Assignee does hereby accept, the entire right, title and interest of Assignor in and to the Marks, together with the goodwill of the business in connection with which the Marks are used and all rights of enforcement and recovery for past, present or future infringements or unauthorized uses of the Marks and the right to collect and retain the proceeds therefrom, and the Registrations, including any renewals and extensions thereof.

Assignee will be responsible for any fees and expenses for the recording of this Agreement with the appropriate trademark offices and/or registrars. Assignor will reasonably cooperate with Assignee, at Assignor's expense, including performance of any other actions, and the execution and delivery of any other documents, requested by Assignee in writing and reasonably necessary or appropriate to give effect to the intent and terms of this Agreement.

The execution and delivery of this Agreement shall not, in any way, affect or limit the rights and obligations of Assignor and Assignee under, or enlarge, restrict or otherwise modify the terms of the Purchase Agreement, or in any way, affect or limit the rights and obligations of the Texas Rangers Major League Baseball Club under, or enlarge, restrict or otherwise modify the terms of the current Agency Agreement by and among Major League Baseball Properties, Inc., the various Major League Professional Baseball Clubs and the Office of the Commissioner of Baseball (and the Operating Guidelines related thereto) (as amended, restated, supplemented or otherwise modified from time to time pursuant to its terms).


This Agreement may be executed in counterpart copies and receipt by facsimile transmission of executed copies will be legally binding.




