Assignment Agreement

By and between
Continental Aktiengesellschaft,

– hereinafter “Continental” –

and

Continental Reifen Deutschland GmbH,
Vahrenwalderstr. 9,
30169 Hannover,
Germany

– hereinafter “CRD” –

Preamble

WHEREAS, Continental has transferred certain assets and intellectual property rights to CRD on the basis of the contribution agreement (Einbringungsvertrag) dated August 2, 2009.

WHEREAS, Continental is the registered owner of intellectual property right applications and/or registrations set out in **Annex A**, including the goodwill associated therewith, any common law rights in the marks corresponding to the applications and/or registrations, and the right to sue for past damages with respect to infringement of any of the foregoing, (hereinafter referred to as “Contract IP-Rights”),

AND WHEREAS, CRD desires to obtain the Contract IP-Rights and Continental is willing to assign the Contract IP-Rights upon the terms and conditions set out herein.

NOW THEREFORE, in view of the foregoing the parties agree to the following:

1. Assignment and Transfer of the Contract IP-Rights

(1) Continental hereby assigns all the rights in connection with the Contract IP-Rights to CRD and CRD hereby accepts the assignment of the Contract IP-Rights, effective as of August 2, 2009.

2. Representations and Warranties

(1) Continental represents and warrants that it is the owner of the Contract IP-Rights.

(2) Continental represents and warrants that the registration status of the Contract IP-Rights set forth in Annex A of this agreement is correctly provided.

3. Price and Costs

(1) CRD shall pay to Continental the assignment price of 1 Euro (in words: one Euro) inclusive of statutory value added tax for the Contract IP-Rights.

(2) CRD shall bear the costs and fees for the transfer of the Contract IP-Rights, unless otherwise agreed between the parties.


4. Miscellaneous

(1) This contract is governed exclusively by German law without giving effect to principles of conflict of laws.

(2) The court in Hannover, Germany shall have exclusive jurisdiction and venue over disputes arising from or in connection with this agreement.

(3) The parties are each aware of the risk that one or more terms of this agreement may, contrary to the current perception of the parties to this agreement, be unenforceable or void. In each such case, the parties would like to exclude any doubt as to the validity of this agreement. Should one or more conditions of this agreement, including this clause, entirely or partially be or become unenforceable or void or should this agreement, contain any omission, the remaining provisions of this agreement shall remain in effect notwithstanding § 139 BGB. The occurrence of inapplicable or invalid provisions obligates the parties to replace these provisions with provisions which most closely reflect their commercial purpose.


