INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

INTELLECTUAL PROPERTY SECURITY AGREEMENT
SUPPLEMENT, dated as of November 16, 2010, by TSA STORES, INC. (the "Grantor"), in favor of BANK OF AMERICA, N.A., in its capacity as collateral agent pursuant to the Credit Agreement identified below (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, reference is made to (i) the Credit Agreement, dated as of May 3, 2006 and amended and restated as of November 16, 2010 (the "Credit Agreement"), among THE SPORTS AUTHORITY, INC., as borrower (the "Borrower"), SLAPSHOT HOLDINGS CORP. ("Holdings"), the lenders from time to time party thereto (the "Lenders"), BANK OF AMERICA, N.A., as administrative agent and Collateral Agent (collectively, in such capacities, the "Agent"), and the other parties thereto, (ii) the Security Agreement, dated as of May 3, 2006 (the "Security Agreement"), among the Borrower, Holdings, the Grantor and certain other Subsidiaries of the Borrower party thereto and the Collateral Agent and (iii) the Reaffirmation Agreement, dated as November 16, 2010 (the "Reaffirmation Agreement"), among the Borrower, Holdings, the Grantor and other Subsidiary of the Borrower party thereto and the Agent.

WHEREAS, pursuant to the terms of the Security Agreement, the Grantor and other parties thereto entered into the Intellectual Property Security Agreement dated as of May 3, 2006, in favor of the Collateral Agent and recorded with the United States Patent and Trademark Office on May 16, 2006 at Reel/Frame 3309/0786 (the "Intellectual Property Security Agreement").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement or the Intellectual Property Security Agreement used herein have the respective meanings assigned thereto in the in the Security Agreement or the Intellectual Property Security Agreement, in each case, as applicable.

SECTION 2. Grant of Security Interest in IP Collateral. The Grantor hereby pledges and grants to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following IP Collateral of such Grantor:

(a) all Trademarks, including, without limitation, the United States trademark registrations and applications of the Grantor listed on Schedule I attached hereto and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark.

SECTION 3. Intellectual Property Security Agreement. The security interest granted pursuant to this Intellectual Property Security Agreement Supplement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Intellectual Property Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Intellectual Property Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Intellectual Property Security Agreement Supplement is deemed to conflict with the Intellectual Property Security Agreement, the provisions of the Intellectual Property Security Agreement shall control.

SECTION 4. Termination. Upon the payment in full of the Secured Obligations (other than any indemnity obligation for unasserted claims that by its terms survives the termination the Credit Agreement) and termination of the Intellectual Property Security Agreement, the Collateral Agent shall execute, acknowledge, and deliver to the Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Intellectual Property Security Agreement Supplement.

SECTION 5. Counterparts. This Intellectual Property Security Agreement Supplement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Intellectual Property Security Agreement Supplement by signing and delivering one or more counterparts.
