INTELLECTUAL PROPERTY ASSIGNMENT

THIS ASSIGNMENT, effective as of October 5, 2010, is by DayMen Photo Marketing LP, a limited partnership formed under the laws of the Province of Ontario ("Assignor") for the benefit of DayMen Canada Acquisition ULC, an unlimited liability corporation incorporated under the laws of the Province of British Columbia ("Assignee"), having its registered office at 2800 Park Place, 666 Burrard Street, Vancouver, British Columbia, Canada, V6C 2Z7.

WHEREAS, Assignor is the owner of all right, title and interest in and to the patent rights listed on Schedule A (the "Patents"), the industrial design rights listed on Schedule B (the "Designs") and the trade-mark rights listed on Schedule C (the "Trade-marks");

AND WHEREAS, in connection with the conveyance and acknowledgement agreement dated the date hereof among the Assignor, the Assignee and 0890859 B.C. Unlimited Liability Company, the Assignee became the sole partner of the Assignor, the Assignor was dissolved and all of the assets and liabilities of the Assignor were transferred to the Assignee (the "Dissolution");

AND WHEREAS, the Assignor and the Assignee wish to acknowledge and agree to the transfer of all of the intellectual property owned by the Assignor to the Assignee in connection with the Dissolution;

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and obligations set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto acknowledge and agree as follows:

1. Assignment of Patents. Assignor assigns to Assignee all of its worldwide right, title and interest in and to the Patents, including, without limitation: (a) any national phase entries, divisionals, continuations, continuations-in-part, reissues or re-examinations thereof; (b) all rights of priority based on the Patents; and (c) all claims for past, present or future infringement of the Patents and any related claims Assignor may have against any third parties, whether known or unknown, and the right to apply any damages recovered to the Assignee's account.

2. Assignment of Designs. Assignor hereby assigns to Assignee all of its worldwide right, title and interest in and to the Designs, including, without limitation: (a) any divisionals thereof; (b) all rights of priority based on the Designs; and (c) all claims for past, present or future infringement of the Designs and any related claims Assignor may have against any third parties, whether known or unknown, and the right to apply any damages recovered to the Assignee's account.

3. Assignment of Trade-marks. Assignor hereby assigns to Assignee all of its worldwide right, title and interest in and to the Trade-marks and the goodwill relating thereto, including without limitation the registrations and applications listed in Schedule C and the right to make applications for any of the Trade-marks in any country or region. Further, Assignor

hereby assigns to Assignee all rights of priority in and to the Trade-marks, together with all claims for past, present or future infringement of the Trade-marks, any rights of opposition relating to the Trade-marks, and any related claims Assignor may have against any third parties, whether known or unknown, and the right to apply any damages recovered to the Assignee's account.


4. Assignment of Other Intellectual Property. Assignor hereby assigns to Assignee all of its worldwide right, title and interest in and to any other intellectual property (whether or not registered) owned by the Assignor, including, without limitation, all inventions (whether or not patentable), trademarks, industrial designs, know-how, trade secrets, original works in which copyright subsists, and the right to make applications to protect any of the foregoing in any country or region (collectively, "Other Intellectual Property"). Further, Assignor hereby assigns to Assignee all rights of priority in and to the Other Intellectual Property, together with all claims for past, present or future infringement of the Other Intellectual Property and any related claims Assignor may have against any third parties, whether known or unknown, and the right to apply any damages recovered to the Assignee's account.

5. Governing Law. This Agreement shall be construed and enforced in accordance with, and the rights of the parties hereto shall be governed by, the laws of the Province of Ontario and the laws of Canada applicable therein.

6. Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
